STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Bell County is current as of January 3, 2023. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85884 on March 19, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

US 25E, from the Tennessee State Line via the Cumberland Gap Tunnel, 12th Street in Middlesboro, Ferndale, and in Pineville, to the Knox County Line, a distance of 18.651 miles. (MP 0.000 to MP 18.651)

US 119, from the junction with US 25E near Pineville, via East Pineville and Callaway, to the Harlan County Line, a distance of 15.880 miles. (MP 0.000 to MP 15.880)

**STATE SECONDARY SYSTEM**

KY 66, from the junction with US 25E just south of the bridge over the Cumberland River in Pineville, via Arjay, Rella, and Crockett to the Clay County Line, a distance of 18.424 miles. (MP 0.000 to MP 18.424)

KY 74, from the intersection with CR 1270 (Hignite Hollow Road), via Edgewood and Middlesboro, to the junction with US 25E, a distance of 5.462 miles. (MP 11.291 to 16.753)

KY 92, from the Whitley County Line via Ingram and Timsley to the junction with US 25E south of the Knox County Line, a distance of 11.160 miles. (MP 0.000 to MP 11.160)

KY 186, from the Tennessee State Line, via Yellow Creek and Premier, and via Winchester Avenue and 40th Street in Middlesboro, to the junction with KY 74, a distance of 2.977 miles. (MP 0.000 to MP 2.977)

KY 190, from the Tennessee State Line via Frakes, and Chenoa to the junction with US 25E, south of Pineville, a distance of 21.573 miles. (MP 0.000 to MP 21.573)

KY 221, from the junction with KY 66 at Straight Creek via Jenson and Stoney Fork to the Harlan County Line, a distance of 12.633 miles. (MP 0.000 to MP 12.633)

KY 441, from the intersection with KY 2402 in Middlesboro to the junction with US 25E in Middlesboro, a distance of 0.640 mile. (MP 4.257 to MP 4.897)

KY 987, from the junction with US 119, via Miracle to the intersection with KY 217, a distance of 8.795 miles. (MP 4.576 to MP 13.371)

KY 2079, from the junction with KY 3502 in Middlesboro to the junction with KY 441, a distance of 3.212 miles. (MP 0.000 to MP 3.212)

KY 2129, from the junction with KY 74 in Middlesboro extending northeast to the junction with KY 441, a distance of 1.094 mile. (MP 0.000 to MP 1.094)

KY 2402, from the junction with KY 74 in Middlesboro to the junction with KY 441, a distance of 1.392 miles. (MP 0.000 to MP 1.392)

**RURAL SECONDARY SYSTEM**

KY 72, from the junction with US 119, via Blackmont Hulen and Tuggleville to the Harlan County Line, a distance of 3.371 miles. (MP 0.000 to MP 3.371)

KY 74, from the Tennessee State Line, via Capito to the intersection with CR 1720 (Hignite Hollow Road), a distance of 11.291 miles. (MP 0.000 to 11.291)

KY 188, from the junction with US 25E near Meldrum to a point east of KY 516 at Colmar, a distance of 4.066 miles. (MP 0.000 to MP 4.066)

KY 217, from the junction with KY 988 via Hutch to the junction with KY 987 northwest of Cubage, a distance of 8.789 miles. (MP 0.000 to MP 8.789)

KY 225, from the junction with KY 92, southwest of Ingram to the Knox County Line, a distance of 1.378 miles. (MP 0.000 to MP 1.378)

KY 441, from the junction with KY 74 on the west side of Middlesboro, via Belt Line Road, to the intersection with KY 2402 in Middlesboro, a distance of 4.257 miles. (MP 0.000 to MP 4.257)

**BELL COUNTY**

KY 516, from the junction with KY 188 west of Colmar extending north to the end of state maintenance, a distance of 1.305 miles. (MP 0.000 to MP 1.305)

KY 535, from the junction with KY 74, northeast of the Tennessee State Line, to the end of state maintenance near Fonde, a distance of 0.600 mile. (MP 0.000 to MP 0.600)

KY 987, from a junction with US 119 near East Pineville, extending eastward to another junction with US 119. Also, from the intersection with KY 217, via Cubage to the Harlan County Line, a distance of 10.560 miles. (MP 0.000 to MP 4.576)(MP 13.371 to MP 19.355)

KY 988, from the beginning of state maintenance at the Cumberland Gap National Historic Park Boundary, extending in a northerly direction to the junction with KY 188, a distance of 1.701 miles. (MP 0.000 to MP 1.701)

KY 1344, from the junction with KY 217 to the junction with US 119 near Calvin, a distance of 5.634 miles. (MP 0.000 to MP 5.634)

KY 1491, from the junction with KY 190 extending west and north, via Clear Creek Springs to another junction with KY 190, a distance of 2.332 miles. (MP 0.000 to MP 2.332)

KY 1534, from the junction with US 25E at Ferndale, via Ponza to the junction with KY 1344 at Calvin, a distance of 5.840 miles. (MP 0.000 to MP 5.840)

KY 1595, from the junction with KY 190 to a point on the Whitley County line. Also, from a point on the Whitley County Line to another point on the Whitley County Line, a distance of 1.486 miles. (MP 0.000 to MP 0.068)(MP 0.068 to MP 1.486)

KY 1599, from the junction with KY 74 in Middlesboro, via Airport Road, to the junction with KY 441, a distance of 0.871 mile. (MP 0.000 to MP 0.871)

KY 1630, from the junction with KY 221 via Kettle Island to the end of state maintenance approximately 0.7 mile north of Kettle Island, a distance of 1.300 miles. (MP 0.000 to MP 1.300)

KY 2011, from the junction with KY 221 near Stoney Fork via Beverly to the junction with KY 66, south of the Clay County Line, a distance of 9.006 miles. (MP 0.000 to MP 9.006)

KY 2133, from the beginning of state maintenance northwest of KY 66 near Blanche to the junction with KY 66, north of Arjay, a distance of 0.814 mile. (MP 0.000 to MP 0.814)

KY 2394, from the junction with KY 66 north of Pineville, via Dorton Branch Road to the railroad crossing, a distance of 0.636 mile. (MP 0.000 to MP 0.636)

KY 3482, from the junction with KY 987 northwest of Miracle to the junction with US 119 west of Calloway, a distance of 1.410 miles. (MP 0.000 to MP 1.410)

KY 3483, from the junction with KY 1595 near the Whitley County Line to the junction with KY 190 southwest of Frakes, a distance of 0.800 mile. (MP 0.000 to MP 0.800)

KY 3484, from the junction with KY 190 northeast of Frakes to the junction with KY 3485, a distance of 3.567 miles. (MP 0.000 to MP 3.567)

KY 3485, from the junction with KY 74 to the junction with KY 190 west of Chenoa, a distance of 4.554 miles. (MP 0.000 to MP 4.554)

KY 3486, from the junction with KY 441 in Middlesboro, via Old Pineville Road, and Meldrum to the junction with US 25E, a distance of 3.728 miles. (MP 0.000 to MP 3.728)
