STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Boone County is current as of February 14, 2024. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86382 on October 29, 1981 and OFFICIAL ORDER # 86971 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

KY 237, from the intersection with US 42 at Sugartit, via Hebron, to the intersection with KY 2846 north of I-275, a distance of 9.487 miles. (MP 1.588 to MP 11.075)

KY 536, from the intersection with US 42 in Union to the intersection with US 25 south of Devon, a distance of 3.275 miles. (MP 10.930 to 14.205)
