STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Boyle County is current as of October 31, 2024. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85588 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 68, from the Marion County Line to the junction with US 150, a distance of 6.499 miles. (MP 0.000 to MP 6.499)

US 127, from the Lincoln County Line via Junction City, Hustonville Road and N Third Street in Danville to the intersection with US 150 and S Maple Avenue. (Including the one-way couplet in Danville of south on Fourth Street from Main Street to the junction with Third Street). Also, from the intersection with US 127 Bypass northwest of Danville to the Mercer County Line, a distance of 8.214 miles. (MP 0.000 to MP 5.978)(MP 8.083 to MP 10.319)

US 127B (Bypass), from the junction with US 127 south of Danville to the junction with US 127 (Harrodsburg Road) north of Danville, a distance of 5.270 miles. (MP 0.000 to MP 5.270)

US 150, from the Washington County Line, via to the intersection of US 68 and South Buell Street in Perryville. Also, from the intersection of KY 1856 and US 68, via Perryville Road and, via Needmore, Atoka, and Davis Hill to the junction with US 127 (N Maple Avenue) in Danville. Also, from US 127, via Stanford Road in Danville to US 150B. Also from US 150B to the Lincoln County Line, a distance of 18.505 miles. (MP 0.000 to MP 4.234)(MP 4.234 to MP 13.508)(MP 13.508 to MP 16.441)(MP 16.441 to MP 18.505)

US 150B (Bypass), from the junction with US 127 south of Danville to the junction with US 150 east of Danville, a distance of 2.272 miles. (MP 0.000 to MP 2.272)

KY 34, from the intersection of East Main Street and US 150 in Danville, via Lexington Avenue in Danville, east to the Garrard County Line, a distance of 5.417 miles. (MP 13.629 to MP 19.046)

STATE SECONDARY SYSTEM

US 127, from the intersection of US 150 and South Maple Avenue in Danville, via Maple Avenue to the intersection with the US 127B (Bypass), a distance of 2.105 miles. (MP 5.978 to MP 8.083)

US 68, from the intersection with US 150 and KY 1856 to the Mercer County Line, a distance of 3.331 miles. (MP 6.499 to MP 9.830)

KY 33, from the intersection of US 150 and US 127 in Danville extending north to the Mercer County Line, a distance of 4.989 miles. (MP 0.000 to MP 4.989)

KY 34, from the junction with US 68, northeast of the Marion County Line, via Brumfield and Mitchellsburg and via Lebanon Road in Danville, to the intersection with US 150 (Main Street), a distance of 13.629 miles. (MP 0.000 to MP 13.629)

KY 52, from the junction with US 150 to the Garrard County Line, a distance of 5.114 miles. (MP 0.000 to MP 5.114)

KY 2168, from the junction with US 127, near Danville, extending east to the junction with KY 34, a distance of 3.088 miles. (MP 0.000 to MP 3.088)

KY 2324, from the junction with KY 33 (Third Street) in Danville, via Lexington Avenue to the junction with KY 34, a distance of 0.423 mile. (MP 0.000 to MP 0.423)

RURAL SECONDARY SYSTEM

KY 37, from the junction with KY 243, via Forkland and Junction City to the junction with KY 127B (Bypass), a distance of 18.730 miles. (MP 0.000 to MP 18.730)

KY 243, from the Casey County Line near the junction with KY 37 northwest to the Marion County Line, a distance of 1.456 miles. (MP 0.000 to MP 1.456)

KY 300, from the junction with KY 34 near Parksville, via Alum Springs to the junction with KY 37 in Junction City. Also, from the junction with KY 37 to the Lincoln County Line, a distance of 6.438 miles. (MP 0.000 to MP 5.091)(MP 5.091 to MP 6.438)

KY 590, from the Lincoln County Line to the junction with KY 52 at Hedgeville, a distance of 0.796 mile. (MP 0.000 to MP 0.796)

KY 1108, from the junction with KY 37 to the junction with KY 34, a distance of 3.718 miles. (MP 0.000 to MP 3.718)

KY 1273, from the junction with KY 300 in Junction City, via Junction City to the Lincoln County Line. Also, from another point on the Lincoln County Line to the junction with US 150. Also, from another junction with US 150, southeast of Danville, via Chrisman Lane to the junction with KY 52, a distance of 5.159 miles. (MP 0.000 to MP 1.289)(MP 1.289 to MP 1.455)(MP 1.455 to MP 5.159)

KY 1805, from the junction with KY 52 to the junction with KY 34 in Danville, a distance of 2.712 miles. (MP 0.000 to MP 2.712)

KY 1822, from the junction with KY 37 to the junction with KY 34 near Parksville. Also, from another junction with KY 34 northeast of Parksville to the junction with US 150 at Needmore. Also, from another junction with US 150 west of Needmore, via Quirks Run Road, to the Mercer County Line, a distance of 9.169 miles. (MP 0.000 to MP 2.792)(MP 2.792 to MP 6.010)(MP 6.010 to MP 9.169)

KY 1856, from the junction with KY 243 to the intersection of US 150 and US 68 in Perryville, a distance of 9.984 miles. (MP 0.000 to MP 9.984)

KY 1894, from the junction with KY 34 at Brumfield to the junction with US 68, a distance of 2.023 miles. (MP 0.000 to MP 2.023)

KY 1896, from the junction with US 127, near the Mercer County Line, via Faulconer to the junction with KY 33, a distance of 2.637 miles. (MP 0.000 to MP 2.637)

KY 1915, from the junction with US 127 to the Mercer County line, a distance of 3.806 miles. (MP 0.000 to MP 3.806)

KY 1920, from the Mercer County Line, via Battlefield Road, to the junction with US 150 in Perryville, a distance of 2.814 miles. (MP 0.000 to MP 2.814)

KY 1941, from the junction with US 68 to the Mercer County Line, a distance

of 0.044 mile. (MP 0.000 to MP 0.044)

KY 3365, from the junction with KY 37 near Junction City, via Hogue Hollow Road, to the junction with KY 300 near Alum Springs, a distance of 2.343 miles. (MP 0.000 to MP 2.343)

KY 3366, from the junction with US 150, via Bluegrass Pike, to the junction with KY 1915, a distance of 3.371 miles. (MP 0.000 to MP 3.371)

SUPPLEMENTAL ROADS

KY 3042, from the west limits of the Chenault Bridge over Herrington Lake in Boyle County, via the bridge structure extending to the Garrard County Line, a distance of 0.104 mile. (MP 0.000 to MP 0.104)
