STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Bracken County is current as of February 20, 2020. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86381 on October 29, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

KY 9, from the Mason County Line extending northwest via the John Y. Brown, Jr. AA Highway, to the Pendleton County Line, a distance of 19.857 miles. (MP 0.000 to MP 19.857)

**STATE SECONDARY SYSTEM**

KY 8, from the Pendleton County Line, via Bradford, Rock Springs, Augusta, and Stoney Point to the Mason County Line, a distance of 18.991 miles. (MP 0.000 to MP 18.991)

KY 10, from the intersection with KY 22 near Willow, via Brooksville to the Mason County Line near Germantown, a distance of 12.942 miles. (MP 7.728 to MP 20.670)

KY 19, from the Harrison County Line to the junction with KY 10 at Powersville. Also, from another junction with KY 10 in Brooksville, to the junction with KY 8 in Augusta, a distance of 17.018 miles. (MP 0.000 to MP 8.553)(MP 8.553 to MP 17.018)

KY 22, from the Pendleton County Line via Neave to the junction with KY 10 near Willow, a distance of 4.387 miles. (MP 0.000 to MP 4.387)

KY 165, from the Robertson County Line to the junction with KY 19, south of Powersville, a distance of 3.456 miles. (MP 0.000 to MP 3.456)

KY 1159, from the junction with KY 10 in Brooksville, via Bladeston to the intersection with KY 9 at Woolcott, a distance of 4.336 miles. (MP 0.000 to MP 4.336)

KY 2228, from the junction with KY 9 to the junction with KY 8, northwest of Foster, a distance of 0.287 mile. (MP 0.000 to MP 0.287)

### **RURAL SECONDARY SYSTEM**

KY 10, from the Pendleton County Line at Lenoxburg, via Berlin to the intersection with KY 22 near Willow, a distance of 7.728 miles. (MP 0.000 to MP 7.728)

KY 435, from the Mason County Line to the junction with KY 8 in Augusta, a distance of 6.688 miles. (MP 0.000 to MP 6.688)

KY 539, from the Robertson County Line at Sante Fe to the junction with KY 19 near Milford. Also, from another junction with KY 19 near Milford to the junction with KY 22 near Neave, a distance of 10.349 miles. (MP 0.000 to MP 3.204)(MP 3.204 to MP 10.349)

KY 616, from a point on the Mason County Line, extending northward to another point on the Mason County Line. Also, from a third point on the Mason County Line to the junction with KY 875 south of Germantown, a distance of 1.522 miles. (MP 0.000 to MP 0.639)(MP 0.639 to MP 1.522)

KY 875, from the Robertson County Line at Bridgeville, via Stonewall, to a junction with KY 10 in Germantown. Also, from another junction with KY 10, northwest of Germantown to the junction with KY 19 in Chatham. Also, from another junction with KY 19 west of Chatham, via Mount Zion Road, Gertrude, and Shofstall Road to the junction with KY 1159 north of Woolcott, a distance of 17.253 miles. (MP 0.000 to MP 6.183)(MP 6.183 to MP 11.515)(MP 11.515 to MP 17.253)

KY 1011, from the junction with KY 10 northwest of Berlin, via Cumminsville, to the junction with KY 1159 at Bladeston, a distance of 5.331 miles. (MP 0.000 to MP 5.331)

KY 1019, from the junction with KY 10 at the Pendleton County Line near Lenoxburg to the junction with KY 8 at Foster, a distance of 5.209 miles. (MP 0.000 to MP 5.209)

KY 1109, from the junction with KY 10, via Johnsville, to the junction with KY 8 at Bradford, a distance of 5.840 miles. (MP 0.000 to MP 5.840)

KY 1159, from the intersection with KY 9 at Woolcott to the junction with KY 8 near Wellsburg, a distance of 2.760 miles. (MP 4.336 to MP 7.096)

Also, from the junction with KY 1109 near Johnsville, via Wallcott-Johnsville Road, to the junction with KY 1159 north of Woolcott, a distance of 6.881 miles. KY 2370, from the junction with KY 875, southeast of Chatham to the junction with KY 435 in Augusta, a distance of 5.242 miles. (MP 0.000 to MP 5.242)

KY 2897, from the junction with KY 19 at the Robertson County Line, extending eastward to another junction with the Robertson County Line, a distance of 1.750 miles. (MP 0.000 to MP 1.750)

KY 352, from a junction with Parina Pike north of the Robertson County Line to the junction with KY 875 near Stonewall, a distance of 3.253 miles. (MP 0.000 to MP 3.253)

KY 1289, from the junction with KY 1011 to the junction with KY 1109, a distance of 1.263 miles. (MP 0.000 to MP 1.263)

KY 2902, from the Pendleton County Line, via New Zion Road to the junction with KY 10 at Berlin, a distance of 3.018 miles. (MP 0.000 to MP 3.018)
