STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Carter County is current as of September 4, 2024. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85713 on November 10, 1980, and OFFICIAL ORDER # 86975 on August 12, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-64, from the Rowan County Line, east to the Boyd County Line, a distance of 32.147 miles. (MP 148.665 to MP 180.812)

KY 1, from the junction with US 60 in Grayson to the junction with KY 9 (John Y. Brown Jr. AA Highway), north of Grayson, a distance of 1.363 miles. (MP 10.646 to MP 12.009)

KY 7, from the Elliott County Line to the junction with US 60 in Grayson, a distance of 10.865 miles. (MP 0.000 to MP 10.865)

KY 9, from the junction with KY 1 north of Grayson extending northwest, via the John Y. Brown, Jr. AA Highway to the Lewis County Line, a distance of 18.262 miles. (MP 0.000 to MP 18.262)

KY 67 from the junction with I-64 to the Greenup County Line, a distance of 0.335 mile. (MP 0.000 to MP 0.335)

KY 7, from the junction with KY 1, near Pactolus, via Lindsey Chapel to the junction with KY 9. Also, from another junction with KY 9 southeast of Iron Hill to the junction with KY 2 at Gesling, a distance of 10.386 miles. (MP 10.865 to MP 16.648) (MP 16.648 to MP 21.251)

KY 59, from the junction with KY 2 near I-64 to the Lewis County Line, a distance of 1.773 miles. (MP 0.000 to MP 1.773)

KY 174, from the Rowan County Line, via Soldier, Hayward, Enterprise, Silica, Lawton, and Limestone to the junction with US 60, west of Olive Hill, a distance of 9.254 miles. (MP 0.000 to MP 9.254)

KY 182, from the junction with Post Office Ave., via Grahn Rd, to the junction with US 60 at Counts Crossroads. Also, from another junction with US 60, north of Counts Crossroads, via the Carter Caves State Park entrance to the junction with KY 2, northeast of Wesleyville, a distance of 11.032 miles. (MP 4.836 to 8.535) (MP 8.535 to MP 15.868)

KY 773, from the junction with KY 1, via Hitchins, Mount Savage, Carter, and Straight Creek, to the junction with Body Shop Road, west of Denton, a distance of 1.903 miles. (MP 3.505 to MP 5.408)

KY 1947, from the junction with US 60, west of Grayson to the junction with KY 1 near I-64, a distance of 3.398 miles. (MP 0.000 to MP 3.398)
