The routes as designated hereinafter were established by OFFICIAL ORDER # 85587 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

KY 9000 (Bert T. Combs Mountain Parkway), from the junction with I-64, east of Winchester to the Powell County Line, a distance of 11.913 miles. (MP 0.000 to MP 11.913)

US 60, from the intersection with KY 89 in Winchester via Mount Zion and Sewell Shop to the Montgomery County Line near Sewell Shop, a distance of 10.137 miles. (MP 7.029 to MP 17.166)

- KY 1927, from the Fayette County Line to the junction with KY 1923 at Pine Grove. Also, from another junction with KY 1923, via Colby to the junction with KY 627 in Winchester, a distance of 8.022 miles. (MP 0.000 to MP 0.371)(MP 0.371 to MP 8.022)
