STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Clinton County is current as of September 3, 2024. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85507 on August 15, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 127, from the Tennessee State Line, extending north to the Russell County Line, a distance of 21.586 miles. (MP 0.000 to MP 21.586)

KY 90, from the Cumberland County Line to a junction with US 127. Also, from another junction with US 127 to the Wayne County Line, a distance of 12.816 miles. (MP 0.000 to MP 5.257)(MP 5.257 to MP 12.816)

STATE SECONDARY SYSTEM

US 127X (Business), from the junction with US 127, north northwest of Bug, extending north through Albany, via Water Street and Washington Street, to the junction with US 127 (including the one-way couplet: Cross Street to Water Street), a distance of 5.862 miles.(MP 0.000 to MP 5.862)

KY 1590, from the junction with US 127X (Business) in Albany to the junction with US 127 at Ida, a distance of 8.392 miles. (MP 0.000 to MP 8.392)

RURAL SECONDARY SYSTEM

KY 200, from the Tennessee State Line, extending north to the Wayne County Line, a distance of 0.396 mile. (MP 0.000 to MP 0.396)

KY 350, from the junction with the US 127 one-way couplet in Albany to a junction with US 127 (including the one-way couplet: Cumberland Street from Cross Street to Washington Street). Also, from another junction with US 127 to the junction with KY 90, west of Cartwright, a distance of 7.256 miles. (MP 0.000 to MP 0.036)(MP 0.036 to MP 7.256)

KY 415, from the junction with Kroger Mountain Road, via Rolan and Cannons Mill to the junction with KY 350, a distance of 6.674 miles. (MP 0.000 to MP 6.674)

KY 553, from the Wisdom Boat Dock on Dale Hollow Reservoir, via Shipley to the intersection with US 127 in Albany, a distance of 7.638 miles. (MP 0.000 to MP 7.638)

KY 558, from the junction with US 127, via Marlow, Cumberland City, and Watauga to the Russell County Line, a distance of 10.753 miles. (MP 0.000 to MP 10.753)

KY 639, from the junction with KY 553 near Shipley, via Wago to the junction with KY 734, a distance of 9.714 miles. (MP 0.000 to MP 9.714)

KY 696, from the junction with US 127, southeast of Albany to the junction with KY 415. Also, from another junction with KY 415, via Savage to the Wayne County Line. Also, from the Wayne County Line to another point on the Wayne County Line, a distance of 7.845 miles. (MP 0.000 to MP 2.990)(MP 2.990 to MP 7.087)(MP 7.087 to MP 7.845)

KY 734, from the junction with US 127 at Snow, via Seventy Six to the junction with US 127 northwest of Ida, a distance of 4.632 miles. (MP 0.000 to MP 4.632)

KY 738, from the Wolf River Dock on Dale Hollow Reservoir near the Tennessee State Line to the junction with US 127 near Albany, a distance of 6.706 miles. (MP 0.000 to MP 6.706)

KY 829, from the junction with KY 90 west of Nora to the junction with KY 558 at Cumberland City, a distance of 3.764 miles. (MP 0.000 to MP 3.764)

KY 968, from the junction with Lick Creek Road near the Tennessee State Line to the junction with KY 415, a distance of 3.793 miles. (MP 0.000 to MP 3.793)

KY 969, from the junction with US 127 south of Bug to the junction with KY 968, a distance of 3.548 miles. (MP 0.000 to MP 3.548)

KY 1009, from the Wayne County Line via Narvel to the junction with KY 829, a distance of 2.502 miles. (MP 0.000 to MP 2.502)

KY 1076, from the junction with US 127 at Static, via Cedar Knob to the junction with KY 969. Also, from another junction with KY 969 to the junction with KY 696, a distance of 3.613 miles. (MP 0.000 to MP 0.952)(MP 0.952 to MP 3.613)

KY 3062, from the junction with KY 734 to the junction with KY 90, a distance of 3.892 miles. (MP 0.000 to MP 3.892)

KY 3063, from the junction with US 127 near Desda to the junction with Wells Bottom Road, a distance of 2.643 miles. (MP 0.000 to MP 2.643)

KY 3065, from the junction with KY 738 to the junction with KY 553, a distance of 2.266 miles. (MP 0.000 to MP 2.266)

KY 3066, from the junction with KY 1576 at Huntersville to the junction with US 127, a distance of 2.451 miles. (MP 0.000 to MP 2.451)

KY 3156, from the junction with KY 90/US 127, via Snow to the junction with KY 2063, a distance of 2.000 miles. (MP 0.000 to MP 2.000)

SUPPLEMENTAL ROADS

KY 1281, from the junction with Albany Landing Road to the end of state maintenance, a distance of 3.201 miles. (MP 0.926 to MP 4.127)
