KY 120, from the junction with US 60 (Main Street) in Marion, via East Belleville Street, and via Tribune to the Webster County Line, a distance of 16.589 miles. (MP 0.000 to MP 16.589)

- KY 723, from the Livingston County Line to the junction with KY 297 at Irma. Also, from another point on KY 297 to the junction with KY 135 at Tolu, a distance of 9.866 miles. (MP 0.000 to MP 7.129)(MP 7.129 to MP 9.866)
- KY 838, from the Livingston County Line to the junction with KY 723, a distance of 4.430 miles. (MP 0.000 to MP 4.430)
- KY 855, from the junction with KY 902 to a junction with KY 70 near Frances. Also, from another junction with KY 70 at Frances to the junction with US 60, a distance of 9.770 miles. (MP 0.000 to MP 3.209)(MP 3.209 to MP 9.770)
- KY 902, from the junction with KY 70 near Dycusburg to the Caldwell County Line, a distance of 6.116 miles. (MP 0.000 to MP 6.116)
- KY 1668, from the junction with US 60 to the junction with KY 135, a distance of 7.823 miles. (MP 0.000 to MP 7.823)
