STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Daviess County is current as of June 8, 2022. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85582 on August 15, 1980 and OFFICIAL ORDER # 86978 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

US 231, from the junction with US 60 near Maceo, via the I-165 Bridge, to the northwest end of the bridge structure\*\*\*Note: the end of the bridge is approximately 0.249 mile northwest of the Kentucky-Indiana border\*\*\*, a distance of 3.557 miles. (MP 11.294 to MP 14.851)

US 431, from the McLean County Line, via Livia, Browns Valley and Pettit, to the junction with US 60 (Wendell H. Ford Expressway) in Owensboro, a distance of 11.389 miles. (MP 0.000 to MP 11.389)

KY 54, from the junction with KY 2831 in Owensboro to the intersection with KY 1456 at Dermont, a distance of 4.505 miles. (MP 0.000 to MP 4.505)
