LYON COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Lyon County is current as of <u>August 4, 2021</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85990 on May 11, 1981 and OFFICIAL ORDER # 86985 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

- I-24, from the Livingston County Line via Kuttawa and Eddyville to the Caldwell County Line, a distance of 20.962 miles. (MP 33.880 to MP 54.842)
- I-69, from the junction with I-24 in Eddyville to the Caldwell County Line, a distance of 6.164 miles. (MP 67.530 to MP 73.694)
- US 62, from the Livingston County Line via Kuttawa and Eddyville to the intersection with US 641 at Fairview, a distance of 10.465 miles. (MP 0.000 to MP 10.465)
- US 641, from the junction with US 62 at Fairview to the Caldwell County Line, a distance of 5.715 miles. (MP 0.000 to MP 5.715)

STATE SECONDARY SYSTEM

- US 62, from the intersection with US 641 at Fairview to the Caldwell County Line, a distance of 3.718 miles. (MP 10.465 to MP 14.183)
- KY 93, from the junction with KY 139 at the Trigg County Line to the junction with US 62 in Eddyville, a distance of 16.509 miles. (MP 0.000 to MP 16.509)
- KY 293, from the junction with KY 93 via Saratoga to the Caldwell County Line, a distance of 3.820 miles. (MP 0.000 to MP 3.820)

KY 453, from the south end of the bridge over the Lake Barkley Canal to the Livingston County Line, a distance of 0.399 mile. (MP 0.000 to MP 0.399)

RURAL SECONDARY SYSTEM

- KY 93, from the junction with US 62 near Kuttawa to the junction with KY 819 near Iuka Ferry Road, a distance of 3.885 miles. (MP 16.509 to MP 20.394)
- KY 274, from the Trigg County Line to the junction with KY 93 at Confederate, a distance of 5.749 miles. (MP 0.000 to MP 5.749)
- KY 295, from the junction with US 62 near Kuttawa via Kuttawa and Eddyville to the Crittenden County Line, a distance of 9.434 miles. (MP 0.000 to MP 9.434)
- KY 373, from the junction with US 62 at Eddyville to the junction with KY 1943, a distance of 3.623 miles. (MP 0.000 to MP 3.623)
- KY 730, from the junction with KY 903 to the junction with KY 293 at Saratoga. Also, from the junction with KY 93 to the northwest end of Water Street in Eddyville, a distance of 8.714 miles. (MP 0.000 to MP 6.127)(MP 6.127 to MP 8.714)
- KY 778, from the Trigg County Line to the junction with KY 93, a distance of 2.685 miles. (MP 0.000 to MP 2.685)
- KY 810, from the Lake Barkley Easement Boundary to the junction with US 62 at Suwanee. Also, from another junction with US 62 at Suwanee to the junction with KY 93, a distance of 7.795 miles. (MP 0.000 to MP 4.450)(MP 4.450 to MP 7.795)
- KY 818, from the junction with KY 730 south of Saratoga to the junction with KY 293. Also, from another junction with KY 293 to the junction with US 62 west of the Caldwell County Line, a distance of 6.292 miles. (MP 0.000 to MP 1.766)(MP 1.766 to MP 6.292)
- KY 819, from the junction with KY 93 at Iuka Ferry Road, 2.0 miles east of the Cumberland River, to another junction with KY 93, 0.211 mile northwest of I-24, a distance of 8.031 miles. (MP 0.000 to MP 8.031)
- KY 903, from the junction with KY 93 at Lamasco to the Caldwell County Line, a distance of 2.437 miles. (MP 0.000 to MP 2.437)

- KY 1055, from the junction with KY 730 via Main Street to the junction with KY 93, a distance of 2.726 miles. (MP 0.000 to MP 2.726)
- KY 1271, from the beginning of state maintenance at the U.S. Government Property Line near Lake Barkley to the junction with KY 810 south of Suwanee, a distance of 1.815 miles. (MP 0.000 to MP 1.815)
- KY 1943, from the junction with KY 295 to the junction with US 641, a distance of 6.994 miles. (MP 0.000 to MP 6.994)
- KY 3305, from the junction with KY 93, via Elkhorn Tavern Road and Riley Road to the junction with US 62, a distance of 1.811 miles. (MP 0.000 to MP 1.811)

SUPPLEMENTAL ROADS

- KY 1097, from a point south of KY 93 via McNabb Road to the junction with KY 93 at Lamasco, a distance of 0.894 mile. (MP 0.000 to MP 0.894)
- KY 1113, from the junction with KY 1943 to the Crittenden County Line, a distance of 0.643 mile. (MP 0.000 to MP 0.643)
- KY 1199, from the junction with KY 3171, via Sells Road, to the junction with Pleasant Valley Road, a distance of 1.505 miles. (MP 0.000 to MP 1.505)
- KY 1272, from the junction with KY 903 north of Lamasco to the Caldwell County Line, a distance of 1.854 miles. (MP 0.000 to MP 1.854)
- KY 2611, from 700 feet south of I-69 via Pleasant Valley Road to the Caldwell County Line, a distance of 0.163 mile. (MP 0.000 to MP 0.163)
- KY 3169, from the junction with US 641, extending east to the Eddyville Prison Farm boundary, a distance of 0.380 mile. (MP 0.000 to MP 0.380)
- KY 3171, from the junction with US 62, extending northward to the south gate of the Eddyville State Prison Farm, a distance of 2.350 mile. (MP 0.000 to MP 2.350)
- KY 6008, HOPEWELL ROAD, from the beginning of state maintenance at a point that is 0.287 mile south of the south limits of the bridge over I-24, extending north to another point that is 0.227 mile north of the south limits of the bridge over I-24, a distance of 0.514 mile. (MP 0.000 to MP 0.514)

KY 6010, POPLAR CREEK ROAD, from the beginning of state maintenance at a point that is 0.084 mile south of the south limits of the bridge over I-24, extending north to another point that is 0.168 mile north of the south limits of the bridge over I-24, a distance of 0.252 mile. (MP 0.000 to MP 0.252)

KY 6011, MARY BLUE ROAD, from the junction with US 62 at a point that is southwest of the I-24 interchange, extending eastward to a point that is 0.134 mile east of US 62, a distance of 0.134 mile. (MP 0.000 to MP 0.134)

KY 6012, ELM GROVE CHURCH ROAD, from the beginning of state maintenance at a point that is 0.045 mile south of KY 6011 (Mary Blue Road), extending north to the junction with KY 6011, a distance of 0.045 mile. (MP 0.000 to MP 0.045)

KY 6016, MARY BECK ROAD, from the junction with KY 93, extending southeast and parallel with the north limits of I-24 to a dead-end, a distance of 0.315 mile. (MP 0.000 to MP 0.315)

KY 6017, OLD KY 818, from the junction with KY 93 at a point south of I-24, extending northeast to a dead-end at a point near the south limits of I-24, a distance of 0.191 mile. (MP 0.000 to MP 0.191)

KY 6018, SARATOGA HEIGHTS ROAD, from the junction with KY 6019 (Friendship Road), extending north and parallel with the west limits of I-24 to the end of state maintenance at Bluegrass Heights, a distance of 2.413 miles. (MP 0.000 to MP 2.413)

KY 6019, FRIENDSHIP ROAD, from the beginning of state maintenance at a point that is 0.120 mile west of I-24 to another point that is 0.143 mile east of I-24, a distance of 0.263 mile. (MP 0.000 to MP 0.263)

KY 6020, WYNN ROAD, from the beginning of state maintenance at a point that is 0.139 mile south of I-24 to another point that is 0.316 mile north of I-24, a distance of 0.455 mile. (MP 0.000 to MP 0.455)

KY 6021, FRONTAGE ROAD #6, from the junction with KY 6020 (Wynn Road) at a point that is near the south limits of I-24, extending eastward to a dead-end, a distance of 0.207 mile. (MP 0.000 to MP 0.207)

KY 6022, FRONTAGE ROAD #7, from the junction with KY 1272, extending in an easterly direction and parallel with the north boundary of I-24 for a distance of 0.743 mile. (MP 0.000 to MP 0.743)
