STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Adair County is current as of November 13, 2012. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85509 on August 15, 1980 and OFFICIAL ORDER # 86968 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.
