STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Breathitt County is current as of February 17, 2017. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86757 on May 19, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

KY 15, from the Perry County Line south of Ned, via Watts and Jackson to the Wolfe County Line, a distance of 25.664 miles. (MP 0.000 to MP 25.664)

KY 205, from the junction with KY 15 to the Wolfe County Line, a distance of 6.405 miles. (MP 5.767 to MP 12.172)

KY 52, from the Lee County Line, via Oakdale, Chenowee and Elkatawa, to the junction with KY 30, a distance of 9.674 miles. (MP 0.000 to MP 9.674)

KY 205, from the junction with KY 30 in Jackson to the junction with KY 15, a distance of 2.204 miles. (MP 0.000 to MP 2.204)

KY 476, from the Perry County Line, via Hardshell, to the junction with KY 15 at Lost Creek, a distance of 11.446 miles. (MP 0.000 to MP 11.446)

KY 397, from the junction with KY 1110 west of Haddix to the junction with KY 30, a distance of 3.543 miles. (MP 0.000 to MP 3.543)

KY 540, from the junction with KY 1812 near Keck extending northeast to the end of state maintenance at the intersection with Steel Fork Road, a distance of 3.748 miles. (MP 0.000 to MP 3.748)

KY 541, from the junction with KY 52 near Chenowee, via War Creek and Lawson, to the junction with KY 205, a distance of 8.245 miles. (MP 0.000 to MP 8.245)

KY 542, from the junction with KY 30 near Guage, via Lambric and Evanston, to the Magoffin County Line, a distance of 18.548 miles. (MP 0.000 to MP 18.548)

KY 1094, from the beginning of state maintenance 2.149 miles south of KY 378, via Bays, to the junction with KY 378. Also, from another junction with KY 378 to the Wolfe County Line, a distance of 2.321 miles. (MP 0.000 to MP 2.149)(MP 2.149 to MP 2.321)

KY 1098, from the junction with KY 15 at Quicksand, via Portsmouth, Press, and Wilstacy, to the Knott County Line, a distance of 20.378 miles. (MP 0.000 to MP 20.378)

KY 2469, from the junction with KY 52, near the Lee County Line, via Copebranch to the junction with KY 30 at Shoulderblade, a distance of 12.625 miles. (MP 0.000 to MP 12.625)

KY 3193, from the junction with KY 15 north of Jackson via Wolverine to the junction with KY 205, a distance of 4.477 miles. (MP 0.000 to MP 4.477)

KY 3237, from the junction with KY 30 southwest of Shoulderblade, via Canoe to the junction with KY 1110, a distance of 9.032 miles. (MP 0.000 to MP 9.032)

KY 3324, from the junction with KY 476 near Clayhole to the junction with Noble Creek Road, a distance of 2.251 miles. (MP 0.000 to MP 2.251)
