STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Breckinridge County is current as of January 11, 2018. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85943 on April 21, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

US 60, from the Hancock County Line via Harned, Hardinsburg, Cloverport, and Irvington to the Meade County Line, a distance of 31.811 miles. (MP 0.000 to MP 31.811)

KY 79, from the intersection with KY 259 via Roff and Westview to the junction with US 60 at Harned, a distance of 9.696 miles. (MP 5.294 to MP 14.990)

KY 259, from the Grayson County Line via Madrid and McDaniels to the junction with KY 79, a distance of 7.901 miles. (MP 0.000 to MP 7.901)

**STATE SECONDARY SYSTEM**

KY 79, from the Grayson County Line via Axtel to the intersection with KY 259. Also, from the junction with US 60 in Irvington to the Meade County Line, a distance of 6.996 miles. (MP 0.000 to MP 5.294)(MP 14.990 to MP 16.692)

KY 84, from the junction with KY 401 to the Hardin County Line, a distance of 3.318 miles. (MP 0.000 to MP 3.318)

KY 86, from the intersection with US 60 at Hensley via Stinnettville, Custer, and Dyer to the Hardin County Line, a distance of 10.180 miles. (MP 15.957 to MP 26.137)

KY 105, from the junction with KY 79 to the intersection with KY 261 at McQuady, a distance of 5.606 miles. (MP 0.000 to MP 5.606)

KY 144, from the Hancock County Line to the junction with US 60. Also, from the intersection with KY 259, via Union Star to the intersection with KY 376 at Frymire, a distance of 5.894 miles. (MP 0.000 to MP 0.821)(MP 14.377 to MP 19.450)

KY 259, from the junction with US 60 Hardinsburg, via Sample to the intersection with KY 144 southwest of Union Star, a distance of 14.039 miles. (MP 7.901 to MP 21.940)

KY 261, from the Hancock County Line, via McQuady to the junction with US 60, a distance of 12.144 miles. (MP 0.000 to MP 12.144)

KY 376, from the junction with KY 144 at Frymire to the Meade County Line, a distance of 0.922 mile. (MP 0.000 to MP 0.922)

KY 401, from the junction with KY 259 at Madrid, via Centerview, Hudson, and Constantine to the junction with KY 86 at Dyer, a distance of 10.240 miles. (MP 0.000 to MP 10.240)

KY 737, from the Grayson County Line, via Fisher to the junction with KY 259, a distance of 3.421 miles. (MP 0.000 to MP 3.421)

KY 992, from the intersection with US 60 to the junction with KY 259 in Hardinsburg, a distance of 1.029 miles. (MP 13.822 to 14.851)

### **RURAL SECONDARY SYSTEM**

KY 86, from the junction with KY 144 at Union Star, via Mystic, Lodiburg, and Clifton Mills to the junction with US 60 at Garfield, a distance of 15.957 miles. (MP 0.000 to MP 15.957)

KY 105, from the intersection with KY 261, extending northwest to the intersection with US 60 in Cloverport, a distance of 11.852 miles. (MP 5.606 to MP 17.458)

KY 110, from the Ohio County Line to the Grayson County Line at Falls of Rough. Also, from the Corps of Engineers' boundary line on Rough River Reservoir at the entrance to the Laurel Branch Camping Area to the intersection with KY 259 northwest of McDaniels, a distance of 6.886 miles. (MP 0.000 to MP 5.345)(MP 5.345 to MP 6.886)

KY 477, from the junction with KY 79 near Irvington to the junction with KY 261 near Webster. Also, from another junction with KY 261 near Webster via Raymond to the Meade County Line, a distance of 9.939 miles. (MP 0.000 to MP 2.965)(MP 2.965 to MP 9.939)

KY 629, from the Ohio County Line, via Rockvale and Tar Fork to the junction with KY 992, a distance of 15.972 miles. (MP 0.000 to MP 15.972)

KY 690, from the intersection with KY 79 near Westview, via Fairfield and Custer to the junction with KY 333 at Corners, a distance of 18.941 miles. (MP 0.000 to MP 18.941)

KY 941, from the junction with KY 1238 to the Meade County Line, a distance of 0.082 mile. (MP 0.000 to MP 0.082)

KY 992, from the junction with KY 144 near the Hancock County Line, via Mattingly to a junction with KY 105. Also, from another junction with KY 105 to the intersection with US 60, a distance of 13.822 miles. (MP 0.000 to MP 9.890)(MP 9.890 to MP 13.822)

KY 1238, from the intersection with KY 333 in Bewleyville to the Meade County Line, a distance of 2.031 miles. (MP 0.000 to MP 2.031)

KY 1401, from the junction with US 60 east of Harned, via Woodrow to the junction with KY 86 in Custer, a distance of 10.055 miles. (MP 0.000 to MP 10.055)
