STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Caldwell County is current as of March 17, 2020. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85600 on September 26, 1980 and OFFICIAL ORDER # 86974 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

I-24, from the Lyon County Line to the Trigg County Line, a distance of 2.547 miles. (MP 54.842 to MP 57.389)

I-69, from the Lyon County Line to the Hopkins County Line, a distance of 16.154 miles. (MP 73.694 to MP 89.848)

US 641, from the Lyon County Line, via Fredonia, to the Crittenden County Line, a distance of 4.72 miles. (MP 0.000 to MP 4.72)

STATE SECONDARY SYSTEM

US 62, from the Lyon County Line, via the following streets in Princeton: Main Street, East Court Square, East Market Street, North Jefferson Street, McGoodwin Avenue, Madisonville Street, and Dawson Road; to the Hopkins County Line (including the one-way couplet westbound of West Market Street from North Jefferson Street to West Main Street in Princeton), a distance of 18.277 miles. (MP 0.000 to MP 18.277)

KY 70, from the junction with US 641 in Fredonia to the intersection with KY 91 in Fredonia, a distance of 1.045 mile. (MP 0.000 to MP 1.045)

CALDWELL COUNTY

KY 91, from the Christian County Line, via Friendship and Scottsburg, and via Hopkinsville Street, Hawthorne Street, and East Market Street in Princeton, to the junction with US 62 at East Court Square (including the one-way couplet southbound of East Main Street from East Court Square to Hawthorne Street in Princeton). Also, from another junction with US 62 in Princeton, via White Sulphur and Crider, to the junction with KY 70 in Fredonia, a distance of 23.389 miles. (MP 0.000 to MP 11.849)(MP 11.849 to MP 23.389)

KY 139, from the Trigg County Line, via Hopson, to the junction with US 62 eastbound (West Main Street) in Princeton (including the one-way couplet southbound of West Court Square from West Market Street to West Main Street in Princeton), a distance of 11.670 miles. (MP 0.000 to MP 11.670)

KY 293, from the Lyon County Line, via South Jefferson Street in Princeton, to the junction with KY 139. Also, from the junction with US 62 in Princeton, via Needmore, to the junction with KY 70 at Fryer, a distance of 17.520 miles. (MP 0.000 to MP 6.151)(MP 6.151 to MP 17.520)

RURAL SECONDARY SYSTEM

KY 70, from the intersection with KY 91 in Fredonia, via Flat Rock and Fryer, to the Hopkins County Line, a distance of 15.238 miles. (MP 1.045 to MP 16.283)

KY 126, from the Trigg County Line, via Cobb, to the junction with KY 139, northwest of Hopson, a distance of 7.629 miles. (MP 0.000 to MP 7.629)

KY 128, from the Trigg County Line to the junction with KY 126 near Cobb. Also, from another junction with KY 126, south of Otter Pond, via Otter Pond to the junction with KY 91 at Cedar Bluff, a distance of 6.665 miles. (MP 0.000 to MP 1.233) (MP 1.233 to MP 6.665)

KY 139, from the junction with KY 91, north of Princeton, via Farmersville and Creswell, to the Crittenden County Line, a distance of 14.283 miles. (MP 11.670 to MP 25.953)

KY 276, from the junction with KY 139 at Black Hawk to the Trigg County Line, a distance of 2.411 miles. (MP 0.000 to MP 2.411)

KY 293, from the junction with KY 70, north of Fryer, to the Hopkins County Line, a distance of 2.966 miles. (MP 17.520 to MP 20.486)

KY 506, from the junction with KY 902, west of Creswell, to the Crittenden County Line, a distance of 1.237 miles. (MP 0.000 to MP 1.237)

CALDWELL COUNTY

KY 672, from the junction with KY 126 near Cobb to the junction with US 62 near the Hopkins County Line, a distance of 14.340 miles. (MP 0.000 to MP 14.340)

KY 902, from the Crittenden County Line to the junction with US 641 in Fredonia. Also, from another junction with US 641 in Fredonia, via Enon, to the junction with KY 139 near Creswell, a distance of 13.426 miles. (MP 0.000 to MP 2.090) (MP 2.090 to MP 13.426)

KY 903, from the Lyon County Line to the junction with KY 293, southwest of Princeton, a distance of 4.377 miles. (MP 0.000 to MP 4.377)

KY 1119, from the junction with KY 293, north of Princeton, to the junction with KY 139 near Farmersville, a distance of 5.203 miles. (MP 0.000 to MP 5.203)

KY 1592, from the junction with KY 139, via Webster Road, to the junction with KY 293, a distance of 5.318 miles. (MP 0.000 to MP 5.318)

KY 1603, from the junction with KY 91 at Scottsburg, via Scottsburg Road, to the junction with KY 278, a distance of 0.560 mile. (MP 0.000 to MP 0.560)

KY 1627, from the junction with US 62 at Midway, via Jones-Keeney Road and Mt. Hebron Church Road, to the junction with KY 672 near the Hopkins County Line, a distance of 7.985 miles. (MP 0.000 to MP 7.985)

SUPPLEMENTAL ROADS

KY 278, from the junction with North Highland Avenue in Princeton, via Sandlick Road, to the junction with KY 672, a distance of 7.601 miles. (MP 0.000 to MP 7.601)

KY 514, from the Lyon County Line to the junction with KY 139, northwest of Hopson Also, from another junction with KY 139 at Hopson to the junction with KY 126, northwest of Cobb, a distance of 7.543 miles. (MP 0.000 to MP 3.287)(MP 3.287 to MP 7.543)

KY 515, from the junction with KY 903, via Eddy Creek Church Road, to the junction with KY 139, a distance of 2.666 miles. (MP 0.000 to MP 2.666)

KY 1077, from the junction with KY 70 at Flat Rock to the junction with KY 902. Also, from another junction with KY 902 at Enon to the Crittenden County Line, a distance of 3.165 miles. (MP 0.000 to MP 2.001)(MP 2.001 to MP 3.165)

KY 1272, from the Lyon County Line to the junction with KY 139, northwest of Hopson, a distance of 3.313 miles. (MP 0.000 to MP 3.313)

KY 1451, from the junction with KY 514 to the junction with the KY 1272, a distance of 0.460 mile. (MP 0.000 to MP 0.460)

KY 1495, from the junction with Dulaney Loop Road and Buck Road to the junction with KY 293, a distance of 5.517 miles. (MP 0.000 to MP 5.517)

KY 1857, from the beginning of state maintenance 2.399 miles southeast of KY 91 to the junction with KY 91 near Scottsburg, a distance of 2.399 miles. (MP 0.000 to MP 2.399)

KY 2066, from the junction with KY 672 to the Lake Beshear Dam, a distance of 0.900 mile. (MP 0.000 to MP 0.900)

KY 2068, from a point 500 feet southwest of KY 128, via Rocksprings Road, to the junction with KY 128 north of McGowan, a distance of 0.092 mile. (MP 0.000 to MP 0.092)

KY 2080, from the junction with KY 139 in Princeton, via Cadiz Street, to the junction with KY 91 in Princeton, a distance of 0.574 mile. (MP 0.000 to MP 0.574)

KY 2611, from the Lyon County Line, approximately 0.29 mile north of US 62, via Pleasant Valley Road, to a point 388 feet north, a distance of 0.073 mile. (MP 0.000 to MP 0.073)

KY 2612, from approximately 0.630 mile west of KY 2619 (White School Road), extending east and parallel to I-69 via Longbreak Road, to the junction with KY 2619, a distance of 0.630 mile. (MP 0.000 to MP 0.630)

KY 2613, from a point 1000 feet south of the centerline of I-69, via Longbreak Road, to a point 1038 feet north of the centerline of I-69, a distance of 0.386 mile. (MP 0.000 to MP 0.386)

KY 2617, from the junction with US 62 in Princeton, via Old Fredonia Road, to the entrance to the State Highway Maintenance Garage, a distance of 0.774 mile. (MP 0.000 to MP 0.774)

KY 2618, from a point 0.050 mile north of US 62, via Crider-Dulaney Road, to a point 850 feet north of I-69, a distance of 0.308 mile. (MP 0.000 to MP 0.308)

KY 2619, from a point 1000 feet south of the centerline of I-69, via White School Road, to a point 1100 feet north of the centerline of I-69, a distance of 0.397 mile. (MP 0.000 to MP 0.397)

KY 2620, from a point 0.153 mile west of KY 2613 (Longbreak Road), extending east and parallel to I-69, to the junction with KY 2613 (Longbreak Road), a distance of 0.153 mile. (MP 0.000 to MP 0.153)

KY 2621, from the junction with KY 2611 to a point 214 feet southeast of the beginning, a distance of 0.043 mile. (MP 0.000 to MP 0.043)

KY 3114, from the junction with KY 293 in Princeton, via East Young Street, to the junction with US 62 in Princeton, a distance of 0.204 mile. (MP 0.000 to MP 0.204)

KY 6059, from the junction with KY 139 north of I-24, extending southeast via Blue Springs Road, to the end of state maintenance, a distance of 0.782 mile. (MP 0.000 to MP 0.782)

KY 6060, from the junction with KY 139 north of I-24, extending northwest via Frontage Road #9, to the Lyon County Line, a distance of 0.942 mile. (MP 0.000 to MP 0.942)
