**CAMPBELL COUNTY
STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Campbell County is current as of March 5, 2019. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86383 on October 29, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

I-275, from the north main expansion joint of the Ohio River Bridge in Fort Thomas, extending westerly by southerly to the Kenton County Line at the mid-point of the bridge over the Licking River, a distance of 4.518 miles. (MP 73.061 to MP 77.579)

I-471, from the I-275 eastbound lane overpasses, extending north to the Ohio State Line, a distance of 5.016 miles. (MP 0.000 to MP 5.016)

US 27, from the Pendleton County Line, via Aspen Grove, Alexandria, Cold Spring, Highland Heights, Fort Thomas, Southgate, and in Newport via Monmouth Street, Third Street, and the Taylor-Southgate Bridge to the end of state maintenance at the end of the bridge structure (0.100 mile north of the Kentucky - Ohio State Line), including the one-way couplet southbound in Newport via York Street and Eleventh Street to Monmouth Street, a distance of 22.770 miles. (MP 0.000 to MP 22.770)

KY 8, from the Kenton County Line at the Veterans Memorial Bridge (Fourth Street Bridge) via Fourth Street to the junction with US 27 in Newport (including the one-way couplet westbound of Fourth Street from US 27 to the Veterans Memorial Bridge approach), a distance of 0.683 mile. (MP 0.000 to MP 0.683)

KY 8X, from the junction with US 27 in Newport, via Bellevue to the intersection with Dodd Drive in Dayton, a distance of 2.634 miles. (MP 0.000 to MP 2.634)

KY 9, from the Pendleton County Line extending northwest via Alexandria, Cold Spring, and Wilder to the junction with KY 8 in Newport, a distance of 23.068 miles. (MP 0.000 to MP 23.068)

KY 471, from the junction with US 27 in Highland Heights, extending north to the I-275 eastbound lane overpasses, a distance of 0.698 mile. (MP 0.000 to MP 0.698)

KY 1120, from the Kenton County Line at the Shortway Bridge over the Licking River via West Eleventh Street to the junction with the US 27 one-way couplet southbound (York Street). Also, from the junction with the US 27 one-way couplet southbound (York Street) via East Tenth Street and Memorial Parkway in Newport to the junction with I-471, a distance of 1.557 miles. (MP 0.000 to MP 0.668)(MP 0.668 to MP 1.557)

STATE SECONDARY SYSTEM

KY 8, from the intersection with US 27 in Cold Springs via Industrial Road to the junction with KY 445 in Silver Grove, then proceeding south through Melbourne, and Mentor to the Pendleton County Line, a distance of 18.947 miles. (MP 0.683 to MP 19.630)

KY 10, from the junction with KY 915, via Alexandria, to the intersection with KY 1997, a distance of 4.423 miles. (MP 0.000 to MP 4.423)

KY 154, from the junction with US 27, south of Grants Lick, to the Pendleton County Line, a distance of 3.373 miles. (MP 0.000 to MP 3.373)

KY 445, from the junction with KY 8 in Silver Grove, proceeding north to the junction with KY 6335, then north-west to the junction with KY 1120. Also, from another junction with KY 1120, via Grandview Avenue, to the junction with US 27, a distance of 2.438 miles. (MP 0.000 to MP 2.200)(MP 2.200 to MP 2.438)

KY 536, from the Kenton County Line to the junction with US 27 near Alexandria, a distance of 3.445 miles. (MP 0.000 to MP 3.445)

KY 547, from the junction with KY 10 in Alexandria to the junction with KY 8 in Silver Grove, a distance of 6.517 miles. (MP 0.000 to MP 6.517)

KY 709, from the junction with US 27 in Alexandria, extending northerly via East Alexandria Pike, to the junction with KY 9, a distance of 0.476 mile. (0.000 to MP 0.476)

KY 735, from the junction with KY 10 at Flagg Spring to the junction with KY 8

in Mentor, a distance of 0.980 mile. (MP 0.000 to MP 0.980)

KY 915, from the junction with US 27 near Alexandria to the junction with KY 9 in Cold Spring, a distance of 9.295 miles. (MP 0.000 to MP 9.295)

KY 1120, from the intersection with I-471 via Fort Thomas to the junction with US 27, a distance of 4.243 miles. (MP 1.557 to MP 5.800)

KY 1632, from the junction with KY 9 in Wilder to the junction with US 27 in Southgate, a distance of 1.660 miles. (MP 0.000 to MP 1.660)

KY 1892, from the junction with KY 1120 in Fort Thomas, via Grand Avenue and Carothers Road, to the junction with US 27 in Newport, a distance of 2.568 miles. (MP 0.000 to MP 2.568)

KY 1997, from the junction with KY 10 southeast of Alexandria to the intersection with KY 9 east of Alexandria, a distance of 0.880 mile. (MP 0.000 to MP 0.880)

KY 1998, from the junction with KY 9 in Wilder, via Pooles Creek Road and Industrial Road, to the intersection with US 27 in Cold Spring, a distance of 1.738 miles. (MP 0.000 to MP 1.738)

KY 2238, from the junction with US 27 in Highland Heights, via Louie B. Nunn Drive, University Drive, and Three Mile Road by the use of roundabout(s), to the junction with KY 2345 in Wilder, a distance of 2.442 miles. (MP 0.000 to MP 2.442)

KY 2345, from the junction with US 27 in Cold Spring, via Martha Layne Collins Boulevard and John Hill Road but the use of a roundabout, to the junction with KY 9 in Wilder, a distance of 3.316 miles. (MP 0.000 to MP 3.316)

KY 2405, from beginning of State Maintenance, approximately 0.142 mile southwest of the roundabout junction with KY 2345, extending north to the roundabout junction with KY 2238, a distance of 1.070 miles. (MP 1.297 to MP 2.367)

KY 2828, from the junction with KY 9, via Ivor Road, to the Pendleton County line, a distance of 0.466 mile. (MP 0.000 to MP 0.466)

KY 2924, from the junction with US 27 in Alexandria, via Tollgate Road to the junction with KY 915 north of Hawthorne, a distance of 2.757 miles. (MP 0.000 to MP 2.757)

KY 1936, from the junction with US 27 at Grants Lick to the junction with KY 536, a distance of 7.777 miles. (MP 0.000 to MP 7.777)

KY 1996, from the junction with KY 1121, northwest of Persimmon Grove, to the junction with KY 10, southeast of Alexandria. Also, from another junction with KY 10, southeast of Alexandria, to the junction with KY 8, a distance of 4.711 miles. (MP 0.000 to MP 0.997)(MP 0.997 to MP 4.711)

KY 1997, from the intersection with KY 9 east of Alexandria to the junction with KY 547 south of Camp Springs, a distance of 3.712 miles. (MP 0.880 to MP 4.592)

KY 2921, from the junction with KY 1566 east of Alexandria, via North Washington Trace Road and Painter Road, to the junction with KY 8, a distance of 2.223 miles. (MP 0.000 to MP 2.223)

SUPPLEMENTAL ROADS

KY 2925, from the junction with CR 1304B (East Low Gap Road), extending northwest via East Alexandria Pike, to the south city limits of Cold Spring, a distance of 2.083 miles. (MP 0.000 to MP 2.083)
