The routes as designated hereinafter were established by OFFICIAL ORDER # 85506 on August 15, 1980. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

KY 61, from the Tennessee State Line, via Peytonsborg and Burkesville to the Adair County Line (including the one-way couplet around the Court House Square), a distance of 26.075 miles. (MP 0.000 to MP 26.075)

KY 90, from the Metcalfe County Line, via Dubre, Marrowbone, Waterview, and Grider to the junction with KY 61 in Burkesville. Also, from another junction with KY 61, south of Burkesville to the Clinton County Line, a distance of 22.450 miles. (MP 0.000 to MP 14.113) (MP 14.113 to MP 22.450)

KY 953, from the Monroe County Line, via Judio, Stalcup, and Littrell to the junction with KY 61, a distance of 8.888 miles. (MP 0.000 to MP 8.888)

KY 1206, from the entrance to Dale Hollow State Resort Park near Frogue to the junction with KY 449, a distance of 3.802 miles. (MP 0.000 to MP 3.802)

KY 1341, from the junction with KY 61 to the end of state maintenance at the entrance to the Department of Highways Maintenance Barn in Burkesville, a distance of 0.204 mile. (MP 0.000 to MP 0.204)

KY 1351, from the junction with KY 449, east of Modoc, via Green Grove to the Clinton County Line, a distance of 2.966 miles. (MP 0.000 to 2.966)

KY 1424, from the junction with KY 953 at Stalcup to the end of state maintenance at a point west of Cloyds Landing, a distance of 6.490 miles. (MP 0.000 to MP 6.490)

KY 1880, from the junction with KY 90 in Burkesville to another junction with KY 90, near the Clinton County Line, a distance of 14.035 miles. (MP 0.000 to MP 14.035)

KY 2064, from the Hendricks Dock on Dale Hollow Lake to the junction with KY 61, northwest of Peytonsburg, a distance of 0.978 mile. (MP 0.000 to MP 0.978)

KY 3104, from the junction with KY 485 north of Tanbark to another junction with KY 485 north of Ellington, a distance of 2.880 miles. (MP 0.000 to MP 2.880)

KY 3108, from the beginning of state maintenance at the junction with B. W. Long Road to the junction with KY 953 at Littrell, a distance of 4.949 miles. (MP 0.000 to MP 4.949)

KY 2276, from the junction with KY 90, west of Burkesville to the junction with KY 61 at the Court House Square, a distance of 1.669 miles. (MP 0.000 to MP 1.669)
