STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Edmonson County is current as of October 26, 2016. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86608 on March 18, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-65, from a point on the Barren County Line, southeast of Rocky Hill, to another point on the Barren County Line, a distance of 2.628 miles. (MP 43.307 to MP 45.935)

KY 70, from a junction with KY 259, north of the Green River, via North and South Main Street in Brownsville, to another junction with KY 259, a distance of 2.449 miles. (MP 9.939 to MP 12.388)

KY 101, from the Warren County line, via Chalybeate, to the junction with KY 259 east of Rhoda, a distance of 4.075 miles. (MP 0.000 to MP 4.075)

KY 259, from the junction with KY 101 east of Rhoda, to the junction with KY 70 at Brownsville. Also, from another junction with KY 70, north of the Green River, via Lindseyville, Sweeden, Bee Spring and Broadway, to the Grayson County Line, a distance of 13.401 miles. (MP 8.839 to MP 11.676)(MP 11.676 to MP 22.240)

**STATE SECONDARY SYSTEM**

US 31W, from the Warren County Line to the Barren County Line, a distance of 7.996 miles. (MP 0.000 to MP 7.996)

KY 70, from the Butler County Line, via Roundhill, Huff and Windyville, to a junction with KY 259, north of the Green River. Also, from another junction with KY 259 to the intersection with KY 2325 at the Southwest Boundary of the Mammoth Cave Park. Also, from the Southeast Boundary of the Mammoth Cave Park about 780 feet East of an intersection with the South Entrance Road to the Barren County Line, a distance of 14.720 miles. (MP 0.000 to MP 9.939)(MP 12.388 to MP 17.062)(MP 17.062 to MP 17.169)

KY 185, from a point on the Butler County Line near KY 70, extending north to another point on the Butler County Line. Also, from still another point on the Butler County Line, via Big Reedy and Nash, to the Grayson County Line, a distance of 5.710 miles. (MP 0.000 to MP 0.941)(MP 0.941 to MP 5.710)

KY 187, from the junction with KY 70 at Huff, via Sunfish, to the Grayson County Line, a distance of 6.181 miles. (MP 0.000 to MP 6.181)

KY 728, from the junction with KY 259, south of Bee Spring, via the Nolin Dam and Straw, to the Hart County Line, a distance of 12.017 miles. (MP 0.000 to MP 12.017)

### **RURAL SECONDARY SYSTEM**

KY 183, from the junction with KY 70, approximately 764 feet north of the Green River Bridge at Brownsville, to Lock No. 6 at Green River, a distance of 1.284 miles. (MP 0.000 to MP 1.284)

KY 238, from the junction with KY 185 near Big Reedy to the intersection with KY 185 south of Nash. Also, from another junction with KY 185 south of Nash to the junction with KY 187 south of Sunfish. Also from another junction with KY 187 at Sunfish to the junction with KY 259 at Bee Spring, a distance of 12.133 miles. (MP 0.000 to MP 3.497)(MP 3.497 to MP 7.047)(MP 7.047 to MP 12.133)

KY 259, from the Warren County Line, via Rocky Hill, Cedar Spring, and Pig to the junction with KY 101 east of Rhoda, a distance of 8.839 miles. (MP 0.000 to MP 8.839)

KY 422, from the junction with US 31W to the junction with KY 259 at Pig, a distance of 2.909 miles. (MP 0.000 to MP 2.909)

KY 655, from a junction with KY 70, northwest of Windyville, via Segal and Asphalt, to another junction with KY 70 at Windyville, a distance of 9.214 miles. (MP 0.000 to MP 9.214)

KY 743, from the Warren County Line to a junction with KY 101 near Chalybeate. Also, from another junction with KY 101 south of Chalybeate to the junction with KY 422 southwest of Pig, a distance of 8.290 miles. (MP 0.000 to MP 5.060)(MP 5.060 to MP 8.290)

KY 1015, from the junction with KY 728 southeast of Straw, via Union Light Road, to the Hart County Line, a distance of 4.347 miles. (MP 0.000 to MP 4.347)

KY 1075, from the junction with KY 185 at Nash to the junction with KY 187 near the Grayson County Line, a distance of 4.304 miles. (MP 0.000 to MP 4.304)

KY 1339, from the junction with KY 259 at Rocky Hill to the Barren County Line, a distance of 3.831 miles. (MP 0.000 to MP 3.831)

KY 1352, from the North Boundary of the Mammoth Cave Park to the junction with KY 1827, a distance of 1.684 miles. (MP 0.000 to MP 1.684)

KY 1365, from the junction with KY 70, east of Windyville, to the junction with Holly Springs Church Road (CR 1307), a distance of 1.404 miles. (MP 0.000 to MP 1.404)

KY 1749, from the Warren County Line near the Green River to the junction with KY 743, a distance of 9.564 miles. (MP 0.000 to MP 9.564)

KY 1827, from the beginning of State Maintenance at the Brier Creek Boat Ramp parking lot to the junction with KY 728 at Straw. Also, from another junction with KY 728 to the Hart County Line, a distance of 6.603 miles. (MP 0.000 to MP 3.039)(MP 3.039 to MP 6.603)

KY 2067, from the Moutardier Recreation Area Boundary to the Grayson County Line, a distance of 0.748 mile. (MP 0.000 to MP 0.748)

KY 2325, from the junction with KY 259 northwest of Pig, via Silent Grove Church Road, to the junction with KY 70, a distance of 2.023 miles. (MP 0.000 to MP 2.023)

KY 2326, from the Warren County Line to the junction with KY 743, a distance of 2.591 miles. (MP 0.000 to MP 2.591)

KY 2330, from the junction with KY 187 south of Sunfish, via Sunfish Sunny Point Road, to the junction with KY 1075, a distance of 2.408 miles. (MP 0.000 to MP 2.408)

KY 2336, from the junction with KY 728 to the junction with KY 259 at Broadway, a distance of 3.522 miles. (MP 0.000 to MP 3.522)

KY 3019, from a junction with KY 101 via Rhoda to the junction with KY 259 north of Rhoda, a distance of 1.882 miles. (MP 0.000 to MP 1.882)

KY 3021, from a junction with KY 259 to another junction with KY 259, a distance of 1.328 miles. (MP 0.000 to MP 1.328)

**SUPPLEMENTAL ROADS**

KY 2182, from the junction with KY 70 in Brownsville, via Main Cross Street, to the junction with KY 2184, a distance of 0.058 mile. (MP 0.000 to MP 0.058)

KY 2184, from a junction with KY 70 in Brownsville, via Washington Street, to the KY 70 Overpass at the Green River Bridge in Brownsville, a distance of 0.696 mile. (MP 0.000 to MP 0.696)

KY 3611, from the junction with KY 743 to the junction with KY 101, a distance of 0.532 mile. (MP 0.000 to MP 0.532)
