STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Graves County is current as of September 12, 2013. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85987 on May 11, 1981 and OFFICIAL ORDER # 87932 on September 30, 1983. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

JC 9003 (Julian M. Carroll Parkway), from the Hickman County Line to the Marshall County Line, a distance of 26.135 miles. (MP 8.352 to MP 34.487)

KY 121, from the junction with KY 80 and KY 97 via Mayfield to the intersection with US 45 in Mayfield, a distance of 3.439 miles. (MP 5.499 to MP 8.938)

US 45, from the Hickman County Line via Water Valley, Wingo, and Mayfield to the intersection with KY 58 and KY 80 in Mayfield (including the one-way southbound couplet in Mayfield from the junction with KY 80 via South Eighth Street, West Water Street, and South 12th Street to the junction with mainline US 45 at Walnut Street), a distance of 17.219 miles. (MP 0.000 to MP 17.219)

KY 121X (Business), from the junction with KY 80 extending northward to the junction with KY 58 in Mayfield, a distance of 1.870 miles. (MP 0.000 to MP 1.870)

KY 131, from the junction with KY 58 via Westplains, Kaler, and Symsonia to the McCracken County Line, a distance of 14.440 miles. (MP 0.000 to MP 14.440)

KY 303, from the junction with KY 94 via Cuba to the intersection with KY 121X (Business) in Mayfield, a distance of 11.722 miles. (MP 5.131 to MP 16.853)

KY 339, from the junction with KY 97 at Sedalia, via Stubblefield to the junction with US 45 in Wingo. Also, from another junction with US 45 in Wingo to the junction with KY 58 at Holifield, a distance of 10.980 miles. (MP 4.501 to MP 12.334)(MP 12.334 to MP 15.481)

KY 348, from the McCracken County Line via Symsonia to the Marshall County Line, a distance of 5.028 miles. (MP 0.000 to MP 5.028)

KY 1276, from the junction with KY 121 northwest of Mayfield to the junction with US 45 north of Mayfield, a distance of 2.257 miles. (MP 0.000 to MP 2.257)

KY 1830, from the junction with KY 121 north of Mayfield to the junction with US 45 north of Mayfield, a distance of 1.324 miles. (MP 0.000 to MP 1.324)
