STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Grayson County is current as of August 15, 2013. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85944 on April 21, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

WK 9001 (Wendell H. Ford Western Kentucky Parkway), from the Butler County Line to the Hardin County Line, a distance of 31.216 miles. (MP 88.433 to MP 119.649)

US 62, from the junction with KY 259 in Leitchfield, via the Courthouse Square to another junction with KY 259 in Leitchfield. (Including the 0.055 mile non-cardinal couplet of the Courthouse Square from US 62 east to US 62 west), a distance of 0.509 mile. (MP 20.787 to MP 21.296)

KY 259, from the Edmonson County Line, via Moutardier, Anneta, and Meredith to the junction with US 62 in Leitchfield. Also, from another junction with US 62 in Leitchfield, via Eveleigh to the Breckinridge County Line, a distance of 21.459 miles. (MP 0.000 to MP 12.954)(MP 12.954 to MP 21.459)

KY 3155, from the junction with KY 259 south of Leitchfield, via the Leitchfield Bypass to another junction with KY 259 north of Leitchfield, a distance of 4.697 miles. (MP 0.000 to MP 4.697)

STATE SECONDARY SYSTEM

US 62, from the Ohio County Line, via Caneyville, to the junction with KY 259 in Leitchfield. Also, from another junction with KY 259 in Leitchfield via Clarkson to the Hardin County Line, a distance of 33.018 miles. (MP 0.000 to MP 20.787)(MP 21.296 to MP 33.527)

KY 54, from the Ohio County Line, via Short Creek to the junction with US 62 in Leitchfield, a distance of 18.466 miles. (MP 0.000 to MP 18.466)

KY 185, from the Edmonson County Line to the junction with KY 79 in Caneyville, a distance of 8.345 miles. (MP 0.000 to MP 8.345)

KY 187, from the Edmonson County Line, via South to the junction with US 62 west of Leitchfield, a distance of 11.178 miles. (MP 0.000 to MP 11.178)

KY 224, from the junction with US 62 in Clarkson to the Hart County Line, a distance of 11.557 miles. (MP 0.000 to MP 11.557)

KY 226, from the junction with KY 259 at Meredith to the junction with KY 88 at Peonia, a distance of 1.303 miles. (MP 0.000 to MP 1.303)

KY 737, from the junction with KY 259 in Leitchfield, via Lilac to the Breckinridge County Line, a distance of 6.092 miles. (MP 0.000 to MP 6.092)

KY 920, from the junction with US 62 in Leitchfield to the intersection with KY 3155, a distance of 1.397 miles. (MP 0.000 to MP 1.397)

RURAL SECONDARY SYSTEM

KY 110, from the Breckinridge County Line, via Hickory Corner and Falling Branch to the end of state maintenance at a point 0.097 mile east of Fentress Lookout Road, a distance of 4.835 miles. (MP 0.000 to MP 4.835)

KY 411, from the Butler County Line to the junction with KY 185. Also, from another junction with KY 185 via Windyville to the junction with KY 187 near Shrewsbury, a distance of 7.404 miles. (MP 0.000 to MP 1.300)(MP 1.300 to MP 7.404)

KY 479, from the junction with KY 88 near Wax to the junction with KY 224 at Millerstown, a distance of 8.169 miles. (MP 0.000 to MP 8.169)

KY 631, from the junction with KY 54, via Duff to another junction with KY 54 near Short Creek, a distance of 7.758 miles. (MP 0.000 to MP 7.758)

KY 720, from the junction with Floyd Clark Road, via Tar Hill and St. Paul to the junction with US 62 southwest of Big Clifty. Also, from another junction with US 62 northeast of Big Clifty, via Lacon to the Hardin County Line, a distance of 14.053 miles. (MP 0.000 to MP 5.843)(MP 5.843 to MP 14.053)

KY 736, from the junction with KY 79 southwest of Caneyville, and via Do Stop, Spring Lick, and Yeaman to the junction with KY 54. Also, from another junction with KY 54 to the junction with KY 110 south of Falling Branch, a distance of 19.713 miles. (MP 0.000 to MP 11.239)(MP 11.239 to MP 19.713)

KY 878, from the Ohio County Line to the junction with KY 54 near Hites Falls, a distance of 4.624 miles. (MP 0.000 to MP 4.624)

KY 889, from a point southeast of KY 88, via Rocking Hill Estates Road to the junction with KY 88 south of Johnson Crossroads, a distance of 2.813 miles. (MP 0.000 to MP 2.813)

KY 920, from the intersection with KY 3155, via Tar Hill to the Hardin County Line, a distance of 6.469 miles. (MP 1.397 to MP 7.866)

KY 1133, from a point 0.695 mile north of the Edmonson County Line, via Sadler to the junction with KY 187 south of the Wendell H. Ford Western Kentucky Parkway, a distance of 9.077 miles. (MP 0.000 to MP 9.077)

KY 1168, from the junction with KY 224 north of Horntown to the junction with KY 720, a distance of 3.491 miles. (MP 0.000 to MP 3.491)

KY 1214, from the Hart County Line, via Broad Ford and Snap to the junction with KY 88 at Grayson Springs. Also, from another junction with KY 88 at Grayson Springs to the junction with US 62 in Leitchfield, a distance of 14.860 miles. (MP 0.000 to MP 11.195)(MP 11.195 to MP 14.860)

KY 1356, from the junction with KY 88 southeast of Iberia to the junction with KY 1214 southeast of Snap, a distance of 2.880 miles. (MP 0.000 to MP 2.880)

KY 2067, from the Edmonson County Line to the junction with KY 259 at Moutardier, a distance of 0.360 mile. (MP 0.000 to MP 0.360)

KY 2191, from the junction with US 62 in Clarkson to the junction with KY 920, a distance of 2.301 miles. (MP 0.000 to MP 2.301)

KY 2193, from the junction with US 62 at Millwood to the junction with KY 54, a distance of 3.415 miles. (MP 0.000 to MP 3.415)

KY 2766, from the junction with KY 185, via Peth to the junction with KY 187, a distance of 6.323 miles. (MP 0.000 to MP 6.323)
