STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Hart County is current as of January 29, 2018. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85947 on April 21, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-65, from the Barren County Line to the Larue County Line, a distance of 20.666 miles. (MP 53.956 to MP 74.622)

**STATE SECONDARY SYSTEM**

US 31E, from the Barren County Line, via Uno, Hardyville, Canmer, Linwood, and Jonesville to the Larue County Line, a distance of 21.575 miles. (MP 0.000 to MP 21.575)

US 31W, from the Barren County Line, via Horse Cave, Rowletts, and via Main Street in Munfordville, and via Bonnieville to the Larue County Line, a distance of 22.611 miles. (MP 0.000 to MP 22.611)

KY 88, from the Grayson County Line, via Cub Run, Winesap, Kessinger, and via West Street and Center Street in Munfordville to the intersection of Center Street and Main Street in Munfordville. Also, from the intersection with US 31W south of Munfordville via Hardyville and Monroe to the Green County Line, a distance of 30.472 miles. (MP 0.000 to MP 17.807)(MP 17.807 to MP 30.472)

KY 218, from the west end of the interchange with I-65, 2.572 miles west of US 31W in Horse Cave, via Main Street in Horse Cave, and via Seymour, LeGrande, and Three Springs to the Metcalfe County Line, a distance of 13.036 miles. (MP 5.103 to MP 18.139)

KY 224, from the Grayson County Line, via Cash to the Hardin County Line, a distance of 3.282 miles. (MP 0.000 to MP 3.282)

KY 357, from the intersection of US 31W (Main Street) and Union Street in Munfordville, via Union Street in Munfordville, and via Hammonville to the Larue County Line, a distance of 13.031 miles. (MP 0.000 to MP 13.031)

KY 436, from the intersection with KY 218 at LeGrande, via Pascal to the junction with KY 88 near Monroe, a distance of 5.638 miles. (MP 0.000 to MP 5.638)

KY 728, from the Edmonson County Line to the intersection with KY 88 in Cub Run, a distance of 4.044 miles. (MP 0.000 to MP 4.044)

### **RURAL SECONDARY SYSTEM**

KY 218, from the intersection with the Davis Williams Road in Northtown to the west end of the interchange with I-65, a distance of 5.103 miles. (MP 0.000 to MP 5.103)

KY 335, from the Barren County Line to the intersection with KY 218 (Main Street) in Horse Cave. Also, from the intersection with KY 218 near Mammoth Onyx Cave to the intersection with US 31W at Rowletts, a distance of 6.627 miles. (MP 0.000 to MP 2.545)(MP 2.545 to MP 6.627)

KY 566, from the intersection with US 31E at Linwood to the Green County Line, a distance of 4.775 miles. (MP 0.000 to MP 4.775)

KY 569, from the junction with KY 357, via Boiling Springs and Hinesdale to the junction with US 31E near Linwood. Also from another junction with US 31E to the Green County Line, a distance of 10.677 miles. (MP 0.000 to MP 6.427)(MP 6.427 to MP 10.677)

KY 570, from the intersection with KY 218 at LeGrande, via Rex to the intersection with KY 88 near Hardyville, a distance of 5.485 miles. (MP 0.000 to MP 5.485)

KY 571, from the Barren County Line to the junction with KY 218 near Seymour. Also, from another junction with KY 218 near Seymour, via Uno to the junction with US 31W, a distance of 8.099 miles. (MP 0.000 to MP 0.211)(MP 0.211 to MP 8.099)

KY 677, from the Barren County Line to the intersection with KY 218 at Three Springs. Also, from the intersection with KY 218 northeast of Three Springs, via Monroe and Defries to the intersection with US 31E at Canmer, a distance of 12.882 miles. (MP 0.000 to MP 0.180) (MP 0.180 to MP 12.882)

KY 728, from the intersection with KY 88 in Cub Run via Lines Mill and Priceville to the intersection with US 31W north of Bonnieville. KY 1140, from the intersection with US 31W at Munfordville, via Priceville and Riders Mill to the intersection with KY 224, a distance of 13.756 miles. (MP 0.000 to MP 13.756)

KY 1214, from the intersection with KY 728 near Lines Mill to the Grayson County Line, a distance of 2.606 miles. (MP 0.000 to MP 2.606)

KY 1391, from the junction with KY 728, via Wright Lane to Lone Star, and via Bonneville-Lone Star Road to the Hardin County Line, a distance of 6.397 miles. (MP 0.000 to MP 6.397)

KY 1572, from the junction with US 31E south of Canmer, via Gilead-Fairview Road and Rube Smith Road to the junction with KY 677, a distance of 6.179 miles. (MP 0.000 to MP 6.179)

KY 1573, from the intersection with KY 1572 to the intersection with KY 677, a distance of 1.610 miles. (MP 0.000 to MP 1.610)

KY 1827, from the Edmonson County Line, via Bee to the intersection with KY 728 near Cub Run, a distance of 3.639 miles. (MP 0.000 to MP 3.639)

KY 1846, from the Barren County Line, via Short Cut Road in Horse Cave to the junction with US 31W, a distance of 3.802 miles. (MP 0.000 to MP 3.802)

KY 1854, from the intersection with KY 88 to the intersection with US 31E in Canmer, a distance of 3.794 miles. (MP 0.000 to MP 3.794)

KY 2185, from the intersection with KY 357 to the intersection with KY 569 near Hinesdale, a distance of 5.016 miles. (MP 0.000 to MP 5.016)
