STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Henderson County is current as of February 28, 2016. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85597 on September 26, 1980 and OFFICIAL ORDER # 86980 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

I 69, from the Webster County Line extending north to the junction with US 41 near Henderson in Henderson County, a distance of 10.949 miles. (MP 137.141 to MP 148.09)

AU 9005 (Audubon Parkway), from the overpass bridge at the Edward T. Breathitt Parkway, to the Daviess County Line, a distance of 15.883 miles. (MP 0.000 to MP 15.883)

US 41, from the intersection at the terminus of I 69, via the Henderson Bypass to the Indiana State Line, a distance of 9.452 miles. (MP 11.525 to MP 20.977)

US 41A, from the intersection with US 60 via Green Street to the junction with US 60 at the center of the bridge over US 41 in Henderson, a distance of 4.342 miles. (MP 13.094 to MP 17.436)

US 60, from the Union County Line, via Corydon, to the junction with US 41A near Canoe Creek in Henderson, a distance of 10.283 miles. (MP 0.000 to MP 10.283)

KY 425, from the junction with US 60 near the Henderson Community College, via the Henderson Bypass, to the junction with US 41, a distance of 4.747 miles. (MP 0.000 to MP 4.747)

STATE SECONDARY SYSTEM

US 41, from the Webster County Line, proceeding north to the junction with KY 2084, continuing east via the Henderson Bypass to the intersection at the terminus of I 69 in Henderson, a distance of 11.525 miles. (MP 0.000 to MP 11.525)

US 41A, from the Webster County Line, via Rock Springs, to the intersection with US 60 in Henderson, a distance of 13.094 miles. (MP 0.000 to MP 13.094)

US 60, from the junction with US 41A at the center of the bridge over US 41 in Henderson, via Reed, to the Daviess County Line, a distance of 14.828 miles. (MP 10.283 to MP 25.111)

KY 136, from the intersection with KY 359 at Smith Mills, via Geneva to the junction with US 60 in Henderson. Also, from the junction with US 41A (Alternate) in Henderson to the junction with US 41 in Henderson, a distance of 9.723 miles. (MP 12.342 to MP 19.548)(MP 19.548 to MP 22.065)

KY 351, from the intersection of Second Street and US 41A (North Green Street) in Henderson, via Second Street and via Zion to the junction with KY 416 at Hebbardsville, a distance of 12.891 miles. (MP 0.000 to MP 12.891)

KY 359, from the Union County Line to the junction with KY 136 at Smith Mills, a distance of 3.931 miles. (MP 0.000 to MP 3.931)

KY 2084, from the junction with US 41 northbound and KY 425 to the junction with KY 351 (including the southbound couplet from Magnolia Street to US 41 southbound), a distance of 2.953 miles. (MP 0.000 to MP 2.953)

RURAL SECONDARY SYSTEM

KY 136, from the intersection with Alzey-Uniontown Road to the intersection with KY 359 at Smith Mills. Also, from another junction with US 41 at Anthoston, via Niagara, to the north bank of the Green River near the McLean County Line, a distance of 15.266 miles. (MP 5.847 to MP 12.342)(MP 22.065 to MP 30.836)

KY 145, from the Webster County Line to the junction with US 60 in Corydon, a distance of 8.131 miles. (MP 0.000 to MP 8.131)

KY 266, from the junction with KY 136 at Smith Mills, via Corydon to the junction with US 41A at Rock Springs, a distance of 8.304 miles. (MP 0.000 to MP 8.304)

KY 285, from the junction with US 41A to the junction with KY 136 in Henderson, a distance of 2.732 miles. (MP 0.000 to MP 2.732)

KY 416, from the junction with US 41A at Tunnel Hill, via Robards to the western junction with KY 136 at Niagara. Also, from the eastern most junction with KY 136 at Niagara, via Coraville and Hebbardsville, to the northwest bank of the Green River near the Daviess County Line, a distance of 24.446 miles. (MP 0.000 to MP 10.749)(MP 10.749 to MP 24.446)

KY 811, from the junction with US 60 near Beals via Carlinsburg to another junction with US 60 at Reed, a distance of 8.798 miles. (MP 0.000 to MP 8.798)

KY 812, from the junction with KY 1078 south of the Audubon Parkway to the junction with Atkinson Street in Henderson, a distance of 7.935 miles. (MP 0.000 to MP 7.935)

KY 1078, from the junction with New Cash Creek Road to a junction with KY 416, 1.0 mile west of the Audubon Parkway. Also, from another junction with KY 416, to a junction with KY 351 in Zion. Also, from another junction with KY 351 in Zion to a junction with US 60. Also, from another junction with US 60, via Baskett to a third junction with US 60 near Spottsville, a distance of 17.578 miles. (MP 0.000 to MP 2.085)(MP 2.085 to MP 8.797)(MP 8.797 to MP 12.791)(MP 12.791 to MP 17.578)

KY 1299, from the junction with KY 416 west of Robards to the junction with KY 285, south of Henderson, a distance of 9.633 miles. (MP 0.000 to MP 9.633)

KY 2099, from the junction with US 41 in Henderson, via Adams Lane to the junction with KY 812 near the south limits of the Audubon Parkway, a distance of 1.295 miles. (MP 0.000 to MP 1.295)

KY 2183, from the junction with KY 351 at Graham Hill to the junction with US 60, a distance of 3.756 miles. (MP 0.000 to MP 3.756)

KY 2243, from the junction with US 60 west of Spottsville to another junction with US 60 at the west limits of the Spottsville bridge, a distance of 3.019 miles. (MP 0.000 to MP 3.019)

KY 2677, from the beginning of state maintenance northeast of KY 136 near Anthoston via Toy Anthoston Road, extending east and northeast over Edward T. Breathitt Parkway to the end of state maintenance, a distance of 0.592 mile. (MP 0.000 to MP 0.592)

KY 2678, from the junction with US 41 in Robards via Moss and Moss Road to the junction with KY 2096, a distance of 0.659 mile. (MP 0.000 to MP 0.659)

KY 2681, from the junction with KY 2677 (Toy-Anthoston Road) extending northwest and parallel to the east side of the Edward T. Breathitt Parkway to the end of state maintenance, a distance of 1.319 miles. (MP 0.000 to MP 1.319)

KY 2682, from the beginning of state maintenance south of KY 136 on the west side of the Edward T. Breathitt Parkway to the junction with KY 136 near Anthoston, a distance of 1.088 miles. (MP 0.000 to MP 1.088)

KY 2685, from the junction with KY 2686 to the junction with KY 2677 near the east side of the Edward T. Breathitt Parkway, a distance of 0.030 mile. (MP 0.000 to MP 0.030)

KY 2686, from the junction with KY 2685, near the east side of the Edward T. Breathitt Parkway, extending east to the end of state maintenance, a distance of 0.027 mile. (MP 0.000 to MP 0.027)
