HICKMAN COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Hickman County is current as of January 19, 2011. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85988 on May 11, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

JC 9003 (Julian M. Carroll Parkway), from the Fulton County Line to the Graves County Line, a distance of 4.918 miles. (MP 3.434 to MP 8.352)

US 51, from the Fulton County Line via Washington Street in Clinton to the Carlisle County Line, a distance of 15.095 miles. (MP 0.000 to MP 15.095)

KY 80, from the junction with KY 58 in Columbus via East Hoover Parkway to the Carlisle County Line, a distance of 3.443 miles. (MP 0.000 to MP 3.443)

KY 94, from the Fulton County Line to the junction with US 45, a distance of 2.361 miles. (MP 0.000 to MP 2.361)

KY 123, from the junction with KY 58 in Clinton to the intersection with KY 239 southwest of Clinton. Also, from the junction with KY 80 north of Columbus to the Carlisle County Line, a distance of 3.366 miles. (MP 7.853 to MP 10.048) (MP 21.787 to MP 22.958)

KY 703, from the junction with US 51 in Clinton to the junction with KY 307 north of Nichols, a distance of 8.396 miles. (MP 0.000 to MP 8.396)

KY 780, from the junction with US 51 in Clinton to another junction with US 51. Also, from another junction with US 51 to the junction with KY 58, a distance of 6.861 miles. (MP 0.000 to MP 4.059)(MP 4.059 to MP 6.861)

KY 781, from the Fulton County Line to the junction with KY 1529, a distance of 1.950 miles. (MP 0.000 to MP 1.950)

KY 924, from the Fulton County line to the junction with US 51. Also, from the Fulton County Line to the junction with KY 1529, a distance of 3.209 miles. (MP 0.000 to MP 0.028)(MP 0.028 to MP 3.209)

KY 944, from the junction with KY 307 to the junction with KY 1283 at the Graves County Line, a distance of 3.519 miles. (MP 2.861 to MP 6.380)

KY 1037, from the junction with KY 123 to the junction with KY 780 south of Clinton, a distance of 0.633 mile. (MP 0.000 to MP 0.633)

KY 1755, from the junction with KY 1757 (Polk Circle) in Columbus, via Chatham Street, to the junction with Tipton Street, a distance of 0.175 mile. (MP 0.000 to MP 0.175)

KY 1757, from the junction with KY 58 in Columbus, via Polk Circle, to the junction with KY 80, a distance of 0.155 mile. (MP 0.000 to MP 0.155)

KY 1772, from the junction with KY 58 to the Carlisle County Line, a distance of 3.234 miles. (MP 0.000 to MP 3.234)

KY 1825, from the junction with KY 781 at the Fulton County Line to the junction with KY 1529, a distance of 1.990 miles. (MP 0.000 to MP 1.990)

KY 2206, from the junction with KY 703 to the junction with KY 288 at Spring Hill, a distance of 4.071 miles. (MP 0.000 to MP 4.071)
