STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Kenton County is current as of May 17, 2018. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86388 on October 29, 1981 and OFFICIAL ORDER # 86981 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-75, from the Grant County Line to a point on the Boone County Line. Also, from another point on the Boone County Line to the Ohio State Line at the north end of the Brent Spence Bridge, a distance of 11.641 miles. (MP 166.263 to MP 169.439)(MP 183.312 to MP 191.777)

I-275, from the centerline of the interchange with I-75 to the Boone County Line, a distance of 1.582 miles. (MP 0.000 to MP 1.582)

I-275, from the Campbell County Line at the mid-point of the bridge over the Licking River to the centerline of the interchange with I-75, a distance of 6.201 miles. (MP 77.579 to MP 83.780)

US 25, from the Boone County Line via Elsmere, Erlanger, Edgewood, Crestview Hills, Lakeside Park, Fort Mitchell, Fort Wright, Park Hills, and Covington and the Clay Wade Bailey Bridge to the end of state maintenance at the end of the bridge structure (0.026 mile north of the Kentucky - Ohio State Line), a distance of 8.998 miles. (MP 4.978 to MP 13.976)

KY 8, from the intersection with KY 1072 in Ludlow, via Ludlow, and in Covington, via Crescent Avenue, West Fifth Street, Garrard Street, and West Fourth Street to the Campbell County Line at the Veterans Memorial Bridge (West Fourth Street Bridge) over the Licking River (including the westbound one-way couplet on West Fourth Street from Garrard Street to Crescent Avenue), a distance of 3.723 miles. (MP 3.939 to MP 7.662)

KY 16, from the intersection with I-275 in Taylor Mill, via Taylor Mill Road, Winston Avenue, Decoursey Avenue, East 30<sup>th</sup> Street, and James Avenue in Covington, to the junction with KY 17 at 26<sup>th</sup> Street in Covington, a distance of 2.869 mile. (MP 13.002 to MP 15.871)

KY 17, from an intersection with KY 16 at Nicholson, via Madison Pike in Independence, Covington, and Fort Wright, and in Covington: via Madison Avenue, East 20<sup>th</sup> Street, Greenup Street, the "yoke" approach, and the Roebling Bridge to the end of state maintenance at the north curb line of Pete Rose Way in Cincinnati, Ohio (including the southbound one-way couplet of the "yoke" and Scott Street to the junction with East 20<sup>th</sup> Street)(also including the roadway over the railroad-owned tunnel near approximate MP 21.3), a distance of 14.805 miles. (MP 9.516 to MP 24.321)

KY 1120, from the west limits of the I-75 southbound on-ramp in Covington, via West Twelfth Street and East Twelfth Street, to the Campbell County Line at the Shortway Bridge over the Licking River, (including the westbound one-way couplet of Prospect Avenue from East Twelfth Street to East Eleventh Street, East Eleventh Street and West Eleventh Street from Prospect Avenue to Russell Street, and Russell Street from West Eleventh Street to West Twelfth Street), a distance of 1.145 miles. (MP 0.000 to MP 1.145)
