STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Knott County is current as of June 16, 2025. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86842 on July 6, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

HR 9006 (Hal Rogers Parkway), from the Perry County Line, via Big Branch, Montgomery, and Rock Fork to the Floyd County Line, a distance of 20.093 miles. (MP 67.040 to MP 87.133)

KY 15, from the Letcher County Line, via Amelia, Redfox and Carr Creek State Park to the Perry County Line near Sassafras, a distance of 9.329 miles. (MP 0.000 to MP 9.329)

KY 160, from the junction with KY 15, via Carr Creek, Littcarr, Brinkley, and Hindman to the intersection with KY 80, a distance of 12.468 miles. (MP 0.000 to MP 12.468)

**STATE SECONDARY SYSTEM**

KY 7, from the Letcher County Line, via Hall and Kite to the Floyd County Line, a distance of 16.095 miles. (MP 0.000 to MP 16.095)

KY 550, from the Perry County Line near Fisty, via Emmalena, and Carrie to a junction with KY 160 in Hindman. Also, from another junction with KY 160 in Hindman, via Leburn, Larkslane, Mousie, and Porter to the Floyd County Line, a distance of 26.557 miles. (MP 0.000 to MP 11.750)(MP 11.750 to MP 26.557)

KY 582, from the junction with KY 160, via Spider, Pine Top, Nealy, May, Omaha, and Martinsville to the junction with KY 7 at Kite, a distance of 12.729 miles. (MP 0.000 to MP 12.729)

KY 721, from the junction with KY 1088, southeast of Cordia, via Ritchie to the junction with KY 550 at Fisty, a distance of 6.600 miles. (MP 0.000 to MP 6.600)

KY 1087, from the Perry County Line, via Vest and Soft Shell to the junction with KY 550 near Mousie, a distance of 20.469 miles. (MP 0.000 to MP 20.469)

KY 1088, from the Perry County Line, via Cordia and Wiscoal to the junction with KY 15 near Sassafras, a distance of 8.927 miles. (MP 0.000 to MP 8.927)

KY 1091, from the junction with KY 7 to the Floyd County Line, a distance of 2.178 miles. (MP 0.000 to MP 2.178)

KY 1098, from the Breathitt County Line near Decoy, via Baker Camp and Elmrock, to a junction with KY 1087. Also, from another junction with KY 1087 near Soft Shell to the junction with KY 550 at Leburn, a distance of 16.105 miles. (MP 0.000 to MP 11.904)(MP 11.904 to MP 16.105)

KY 1102, from the junction with KY 550 east of Emmalena, to a junction with KY 80 near Montgomery, a distance of 2.686 miles. (MP 0.000 to MP 2.686)

KY 1231, from the junction with KY 15 near Carr Creek State Park via Amburgey to the junction with KY 550, a distance of 8.040 miles. (MP 0.000 to MP 8.040)

KY 1393, from the junction with KY 582 to the junction with KY 899, a distance of 2.757 miles. (MP 0.000 to MP 2.757)

KY 1410, from the junction with KY 160 at Littcarr, via Bath to the Letcher County Line, a distance of 4.710 miles. (MP 0.000 to MP 4.710)

KY 1498, from the junction with KY 7 southeast of Hall to the Floyd County Line, a distance of 1.494 miles. (MP 0.000 to MP 1.494)

KY 3209, from the junction with KY 80 west of Bearville to the junction with KY 1087, a distance of 0.398 mile. (MP 0.000 to MP 0.398)

KY 3391, from the junction with KY 1231 south of Amburgey, via Perkins Madden Road, to the junction with KY 160 southeast of Hindman, a distance of 6.273 miles. (MP 0.000 to MP 6.273)

KY 3392, from the beginning of state maintenance at Duncan Creek, via Lower Mill Creek Road to the junction with KY 550, a distance of 2.896 miles. (MP 0.000 to MP 2.896)
