This listing of the state maintained system by classification in Laurel County is current as of May 8, 2017. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85889 on March 19, 1981 and OFFICIAL ORDER # 86892 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.
