- KY 3387, from the Johnson County Line extending northwest to another junction with the Johnson County Line, a distance of 0.572 mile. (MP 0.000 to MP 0.572)
- KY 3394, from the junction with KY 32 west of Blaine, via Cains Creek Road, and via Hannah and Blevins to the junction with Road Fork Road, a distance of 5.083 miles. (MP 0.000 to MP 5.083)
- KY 3395, from the junction with KY 32 to the junction with US 23 south of Louisa, a distance of 1.658 miles. (MP 0.000 to MP 1.658)
- KY 3396, from the junction with KY 32 west of Louisa to the junction with KY 3 at Five Forks, a distance of 2.41 miles. (MP 0.000 to MP 2.41)
