STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Livingston County is current as of October 30, 2014. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85989 on May 11, 1981 and OFFICIAL ORDER # 86984 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

I-24, from the Marshall County Line to the Lyon County Line, a distance of 4.528 miles. (MP 29.352 to MP 33.880)

US 60, from the McCracken County Line via Ledbetter, Smithland, Burna, and Salem to the Crittenden County Line, a distance of 29.218 miles. (MP 0.000 to MP 29.218)

US 62, from the Marshall County Line via Lake City to the Lyon County Line, a distance of 2.893 miles. (MP 0.000 to MP 2.893)

STATE SECONDARY SYSTEM

KY 453, from the Lyon County Line via Grand Rivers to the intersection with US 60 at Smithland, a distance of 15.641 miles. (MP 0.000 to MP 15.641)

KY 937, from the junction with US 60 to the junction with KY 453, a distance of 2.949 miles. (MP 0.000 to MP 2.949)

RURAL SECONDARY SYSTEM

KY 70, from the junction with US 60 in Smithland via Tiline to the junction with KY 866, a distance of 11.386 miles. (MP 0.000 to MP 11.386)

KY 93, from the junction with KY 917 east of Iuka, via Iuka to the junction with KY 453, a distance of 4.516 miles. (MP 0.000 to MP 4.516)

KY 133, from a point northwest of the Crittenden County Line, via Shelby Road to the junction with US 60 in Salem. Also, from another junction with US 60 at Salem via Lola and Joy to the junction with KY 137, a distance of 18.716 miles. (MP 0.000 to MP 3.834)(MP 3.834 to MP 18.716)

KY 135, from the junction with US 60 at Burna via Hampton to the junction with KY 133 southwest of Joy. Also, from another junction with KY 133 at Joy, via Second Street and Main Street in Carrsville, to the Crittenden County Line, a distance of 13.367 miles. (MP 0.000 to MP 8.232)(MP 8.232 to MP 13.367)

KY 137, from the junction with US 60 north of Smithland, via Birdsville and Bayou to the end of state maintenance at a point 0.111 mile east of the west limits of a structure over Davies Creek, a distance of 19.753 miles. (MP 0.000 to MP 19.753)

KY 723, from the junction with Haynes Park Road near the Cumberland River at Pinckneyville, via Salem to the Crittenden County Line, a distance of 7.368 miles. (MP 0.000 to MP 7.368)

KY 763, from the junction with KY 137 east of Bayou to the junction with US 60 near Burna, a distance of 6.452 miles. (MP 0.000 to MP 6.452)

KY 838, from the junction with KY 135 at Hampton via Lola to the Crittenden County Line, a distance of 6.748 miles. (MP 0.000 to MP 6.748)

KY 866, from the junction with KY 93 to the junction with KY 70 east of Tiline, a distance of 8.741 miles. (MP 0.000 to MP 8.741)

KY 917, from the junction with US 62 near Lake City to the junction with KY 93 east of Iuka. Also, from another junction with KY 93 at Iuka to the junction with KY 866, a distance of 8.297 miles. (MP 0.000 to MP 3.955)(MP 3.955 to MP 8.297)

KY 1433, from the junction with US 60 at Burna via Mullikin Junction to the junction with KY 723 south of Salem, a distance of 10.000 miles. (MP 0.000 to MP 10.000)

KY 1608, from the junction with KY 763 to the junction with KY 135 north of Hampton, a distance of 6.495 miles. (MP 0.000 to MP 6.495)

KY 2225, from the junction with KY 453 via Jake Dukes Road to the junction with KY 93 at Iuka, a distance of 3.661 miles. (MP 0.000 to MP 3.661)

KY 2232, from the junction with KY 866, via Sugar Creek Road, to the junction with KY 70, a distance of 3.146 miles. (MP 0.000 to MP 3.146)

SUPPLEMENTAL ROADS

KY 137, from the junction with KY 135 east of Carrsville to the junction with KY 133, a distance of 4.645 miles. (MP 19.753 to MP 24.398)

KY 453, from the intersection with US 60 in Smithland, via Court Street to the junction with Riverfront Drive, a distance of 0.178 mile. (MP 15.641 to MP 15.819)

KY 952, from the south end of the bridge over the Paducah & Louisville Railway at the north side of Grand Rivers to the junction with US 62 at Lake City, a distance of 1.157 miles. (MP 0.000 to MP 1.157)

KY 967, from the junction with US 60 in Smithland, via Wilson Avenue to the junction with KY 453 (Court Street). Also, from another junction with KY 453 (Court Street) in Smithland, via State Street and Mill Street to the junction with US 60, a distance of 0.474 mile. (MP 0.000 to MP 0.332)(MP 0.332 to MP 0.474)

KY 1436, from the junction with KY 137 to the junction with KY 133 west of Joy, a distance of 5.531 miles. (MP 0.000 to MP 5.531)

KY 1889, from the junction with KY 453, via Heater Store Road to the junction with Coon Chapel Road, a distance of 2.665 miles. (MP 0.000 to MP 2.665)

KY 2610, from the junction with US 60 north of Smithland to the entrance to the Kentucky Department of Highways Maintenance Garage, a distance of 0.175 mile. (MP 0.000 to MP 0.175)

KY 3489, from the junction with US 60 southwest of Gass Road, via Old US 60 Road, to another junction with US 60, a distance of 1.508 miles. (MP 0.000 to MP 1.508)

KY 6004, ACCESS ROAD #5 (FORREST ROAD), from the beginning of state maintenance north of I-24 and west of KY 453, extending eastward to the junction with KY 453, a distance of 0.046 mile. (MP 0.000 to MP 0.046)

KY 6005, ACCESS ROAD #3, from the beginning of state maintenance north of I-24 and west of KY 917, extending eastward to the junction with KY 917, a distance of 0.176 mile. (MP 0.000 to MP 0.176)

LIVINGSTON COUNTY**OCTOBER 30, 2014**

KY 6006, ACCESS ROAD #4 and SERVICE ROAD #1, from the junction with KY 917 south of I-24, extending east to a dead-end, a distance of 0.762 mile. (MP 0.000 to MP 0.762)

KY 6074, from the beginning of state maintenance at a barricade to the junction with US 60, a distance of 0.514 mile. (MP 0.000 to MP 0.514)
