STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in McLean County is current as of June 14, 2017. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85595 on September 26, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 431, from the Muhlenberg County Line, via Adams Avenue in Island and via Livermore and Nuckols to the Daviess County Line, a distance of 11.573 miles. (MP 0.000 to MP 11.573)

STATE SECONDARY SYSTEM

KY 56, from the Webster County Line, via Beech Grove and Elba to the Daviess County Line, a distance of 9.560 miles. (MP 0.000 to MP 9.560)

KY 81, from the Muhlenberg County Line, via Main Street in Sacramento, and via Semiway, Calhoun and Glenville, to the Daviess County Line, a distance of 18.087 miles. (MP 0.000 to MP 18.087)

KY 85, from the Hopkins County Line to the junction with KY 81 south of Sacramento. Also, from another junction with KY 81 in Sacramento, via Buttonsberry and Island to the Ohio County Line, a distance of 12.451 miles. (MP 0.000 to MP 2.632)(MP 2.632 to MP 12.451)

KY 136, from the junction with KY 56 at Beech Grove, via Calhoun, and via Broadway, Morton Avenue, and East Seventh Street in Livermore to the junction with US 431 in Livermore. Also, from another junction with US 431 to the Ohio County Line, a distance of 22.618 miles. (MP 0.000 to MP 19.334)(MP 19.334 to MP 22.618)

KY 138, from the Hopkins County Line to the junction with KY 81 at Rumsey, a distance of 5.862 miles. (MP 0.000 to MP 5.862)

RURAL SECONDARY SYSTEM

KY 138, from the junction with KY 81 in Rumsey to the junction with US 431 near the Livermore Bridge over the Green River, a distance of 8.277 miles. (MP 5.862 to MP 14.139)

KY 140, from the junction with KY 136, southeast of Beech Grove, via Guffie and Glenville to the Daviess County Line, a distance of 10.319 miles. (MP 2.889 to MP 13.208)

KY 250, from the junction with KY 136, east of Calhoun, via Buel to the junction with US 431 north of Nuckols, a distance of 6.943 miles. (MP 0.000 to MP 6.943)

KY 254, from the Hopkins County Line via Ross Street and Second Street in Sacramento to the junction with KY 81 in Sacramento, a distance of 5.312 miles. (MP 0.000 to MP 5.312)

KY 256, from the junction with KY 56 at Beech Grove, via Poverty, and via First Street and Main Street in Calhoun to the junction with KY 81, a distance of 10.542 miles. (MP 0.000 to MP 10.542)

KY 258, from the junction with KY 56, north of Beech Grove to the junction with KY 593. Also from another junction with KY 593, via Delaware Road to the Daviess County Line near the Green River, a distance of 4.330 miles. (MP 0.000 to MP 2.845)(MP 2.845 to MP 4.330)

KY 554, from the junction with KY 815, north of Guffie to the Daviess County Line, a distance of 1.490 miles. (MP 0.000 to MP 1.490)

KY 593, from the junction with KY 56 north of Comer to the intersection with KY 56 at Elba, a distance of 6.996 miles. (MP 0.000 to MP 6.996)

KY 815, from the junction with KY 81 north of Calhoun, via Guffie to the Daviess County Line, a distance of 4.883 miles. (MP 0.000 to MP 4.883)

KY 1080, from the junction with KY 250 via Nuckols to the junction with KY 136 at the Ohio County Line, a distance of 4.844 miles. (MP 0.000 to MP 4.844)

KY 1155, from the junction with KY 254, west of Sacramento, via Poplar Grove to the junction with KY 138 near Rumsey, a distance of 7.638 miles. (MP 0.000 to MP 7.638)

KY 2156, from the junction with KY 140 west of Guffie, via Beulah Road to Cleopatra, and via Cleopatra Road to the Daviess County Line, a distance of 2.427 miles. (MP 0.000 to MP 2.427)

KY 2226, from the junction with KY 81 south of Semiway to the junction with KY 85 west of Buttonsberry, a distance of 2.298 miles. (MP 0.000 to MP 2.298)

KY 2383, from the junction with KY 85, northeast of the KY 81/KY 85 junction at Sacramento, via Bibb Road to the junction with KY 81, a distance of 0.191 mile. (MP 0.000 to MP 0.191)

KY 2385, from the junction with KY 1155 south of Poplar Grove, via Semiway-Faith Road to the junction with KY 81 at Semiway, a distance of 4.436 miles. (MP 0.000 to MP 4.436)

KY 3470, from the junction with KY 81 south of Glenville to the junction with KY 1046, a distance of 0.337 mile. (MP 0.000 to MP 0.337)

KY 796, from the junction with KY 136, via Kidd Lane in Beech Grove to the junction with KY 797, a distance of 1.989 miles. (MP 0.000 to MP 1.989)

KY 797, from the junction with KY 256 near Lemon to the junction with KY 136 east of Beech Grove, a distance of 2.007 miles. (MP 0.000 to MP 2.007)

KY 798, from the junction with KY 136 to the junction with KY 140, a distance of 3.957 miles. (MP 0.000 to MP 3.957)

KY 891, from the junction with KY 85 west of Island to the junction with KY 138, a distance of 2.982 miles. (MP 0.000 to MP 2.982)

KY 1046, from the junction with Richland Road near the Green River to the junction with KY 250. Also, from another junction with KY 250 to the junction with KY 140 near Glenville, a distance of 5.366 miles. (MP 0.000 to MP 2.690)(MP 2.690 to MP 5.366)
