The routes as designated hereinafter were established by OFFICIAL ORDER # 85584 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

KY 686, from the junction with US 460 in Mt. Sterling, extending west and south to the junction with US 460 south of Mt. Sterling, a distance of 3.506 miles. (MP 0.000 to MP 3.506)

US 60, from the Clark County Line, via Mt. Sterling and Ewington to the Bath County Line, a distance of 12.090 miles. (MP 0.000 to MP 12.090)

- KY 537, from the Bourbon County Line, via Judy and Stoops to the Bath County Line near the junction with US 60, a distance of 9.224 miles. (MP 0.000 to MP 9.224)
- KY 599, from the Powell County Line to the junction with US 460 at Jeffersonville, a distance of 6.024 miles. (MP 0.000 to MP 6.024)
