STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Morgan County is current as of February 26, 2018. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86762 on May 19, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

US 460, from the Menifee County Line, via Ezel, Mize, and via Main Street and Prestonsburg Avenue in West Liberty, then southeast via Cottle and White Oak, to the Magoffin County Line, a distance of 28.565 miles. (MP 0.000 to MP 28.565)

KY 519, from the junction with KY 7 near Pomp to the Rowan County Line, a distance of 10.544 miles. (MP 0.000 to MP 10.544)

KY 9009 (Mountain Parkway Extension), from the Wolfe County Line, via the Bert T. Combs Mountain Parkway Extension to the Magoffin County Line, a distance of 5.403 miles. (MP 57.720 to MP 63.123)

KY 772, from the junction with US 460, southwest of Ezel, via Twentysix, and Dehart to the junction with KY 519, a distance of 11.334 miles. (MP 0.000 to MP 11.334)

KY 844, from the junction with KY 205 north of Sellars, via Payton to the junction with KY 191 at Stacy Fork, a distance of 8.756 miles. (MP 0.000 to MP 8.756)
