STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Ohio County is current as of September 10, 2014. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85593 on September 26, 1980 and OFFICIAL ORDER # 86990 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

WK 9001 (Wendell H. Ford Western Kentucky Parkway), from the Muhlenberg County Line near Rockport to the Butler County Line, a distance of 21.869 miles. (MP 65.675 to MP 87.544)

WN 9007 (William H. Natcher Parkway), from the Butler County Line to the Daviess County Line, a distance of 24.410 miles. (MP 37.143 to MP 61.553)

**STATE SECONDARY SYSTEM**

US 62, from the Muhlenberg County Line at Rockport, via McHenry, via First Street and North Main Street in Beaver Dam, and via Rosine to the Grayson County Line, a distance of 25.950 miles. (MP 0.000 to MP 25.950)

US 231, from the Butler County Line, via Cromwell, and via South Main Street in Beaver Dam to the junction with US 62 in Beaver Dam. Also, from another junction with US 62 in Beaver Dam, via South and North Main Street in Hartford to the Daviess County Line, a distance of 24.262 miles. (MP 0.000 to MP 9.999)(MP 9.999 to MP 24.262)

KY 54, from the Daviess County Line, via Reynolds Station, and via West and East Main Street in Fordsville to the Grayson County Line, a distance of 18.244 miles. (MP 0.000 to MP 18.244)

KY 261, from the junction with KY 54 at Ellmitch to the Hancock County Line, a distance of 3.907 miles. (MP 0.000 to MP 3.907)

KY 85, from the junction with KY 69 (Main Street) in Centertown to the junction with US 62 northeast of Rockport, a distance of 4.091 miles. (MP 7.201 to MP 11.292)

KY 110, from the junction with KY 54 at Shreve to the Breckinridge County Line, a distance of 0.980 mile. (MP 0.000 to MP 0.980)

KY 269, from the Butler County Line, via Shultztown and Prentiss to the junction with US 231, a distance of 5.647 miles. (MP 0.000 to MP 5.647)

KY 273, from the junction with KY 69, via Goshen Road and West Seventh Street in Beaver Dam to the intersection with Main Street (US 62) in Beaver Dam, a distance of 3.440 miles. (MP 0.000 to MP 3.440)

KY 369, from the north bank of the Green River, near the Butler County Line, via Cool Springs to the junction with US 231 in Beaver Dam, a distance of 13.170 miles. (MP 0.000 to MP 13.170)

KY 505, from the junction with US 231, via Select, Baizetown, and Windy Hill to a junction with US 62 east of Rosine. Also, from another junction with US 62 east of Rosine to the junction with KY 878 near Olaton, a distance of 17.133 miles. (MP 0.000 to MP 11.758)(MP 11.758 to MP 17.133)

KY 1118, from the Butler County Line, via Flint Springs to the junction with KY 505 at Baizetown, a distance of 2.813 miles. (MP 0.000 to MP 2.813)

KY 1164, from the junction with KY 69, northeast of the William H. Natcher Parkway, to the junction with KY 878, a distance of 7.940 miles. (MP 0.000 to MP 7.940)

KY 1245, from the junction with US 62 in Rockport, via Echols and Nineteen to the junction with US 62 in McHenry, a distance of 6.685 miles. (MP 0.000 to MP 6.685)

KY 1414, from the junction with US 231, via Taffy, Adaburg, and Ralph to the junction with KY 54 southeast of Reynolds Station, a distance of 15.730 miles. (MP 0.000 to MP 15.730)

KY 1543, from the intersection with US 231 (Main Street) in Hartford, via East Union Street and Clay Street in Hartford to the junction with US 62 near the west side of the William H. Natcher Parkway, a distance of 4.381 miles. (MP 0.000 to MP 4.381)

KY 1544, from the junction with US 62 at Rosine to the junction with KY 1164, a distance of 4.588 miles. (MP 0.000 to MP 4.588)

KY 1700, from the intersection with West Main Street (KY 54) in Fordsville to the Hancock County Line, a distance of 4.372 miles. (MP 0.000 to MP 4.372)

KY 1737, from the junction with US 231 north of KY 136 to the junction with KY 1414, a distance of 3.899 miles. (MP 0.000 to MP 3.899)
