STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Robertson County is current as of August 5, 2015. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86391 on October 29, 1983. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

US 68, from the Nicholas County Line to the Fleming County Line, a distance of 1.357 miles. (MP 0.000 to MP 1.357)

**STATE SECONDARY SYSTEM**

US 62, from the Harrison County Line, via Kentontown, and via West Walnut Street and North Main Street in Mt. Olivet to the Mason County Line, a distance of 15.427 miles. (MP 0.000 to MP 15.427)

KY 165, from the junction with US 68 near the Nicholas County Line, via Piqua and via South Main Street in Mt. Olivet to the junction with US 62 (Walnut Street). Also, from another junction with US 62 in Mt. Olivet, via Hittville to the north end of the Licking River Bridge at the Bracken County Line, a distance of 16.378 miles. (MP 0.000 to MP 9.543)(MP 9.543 to MP 16.378)

KY 1504, from the junction with US 62, east of the Harrison County Line, to the junction with US 62, west of Mt. Olivet, a distance of 6.857 miles. (MP 0.000 to MP 6.857)

**RURAL SECONDARY SYSTEM**

KY 539, from the junction with US 62, near Mt. Olivet, via Bratton to the Bracken County Line, a distance of 5.273 miles. (MP 0.000 to MP 5.273)

**ROBERTSON COUNTY**

KY 616, from the junction with KY 1029 to the junction with US 62 east of Mount Olivet. Also, from another junction with US 62 east of Mount Olivet, via Abigail, to the Mason County Line, a distance of 12.318 miles. (MP 0.000 to MP 6.503)(MP 6.503 to MP 12.318)

KY 617, from the junction with US 62 east of Kentontown to the junction with KY 165 near Piqua, a distance of 5.363 miles. (MP 0.000 to MP 5.363)

KY 875, from the junction with KY 165, north of Mt. Olivet, to the Bracken County Line, a distance of 3.079 miles. (MP 0.000 to MP 3.079)

KY 1029, from the junction with KY 165 to the Mason County Line, a distance of 4.829 miles. (MP 0.000 to MP 4.829)

KY 1476, from the junction with KY 617 to the junction with KY 165, south of Mt. Olivet, a distance of 3.605 miles. (MP 0.000 to MP 3.605)

KY 2505, from the Fleming County Line to the junction with KY 1029, a distance of 1.089 miles. (MP 0.000 to MP 1.089)

KY 2897, from the Bracken County Line, via Chapel Road to the junction with KY 539 northwest of Mount Olivet, a distance of 3.953 miles. (MP 0.000 to MP 3.953)

KY 3198, from the junction with US 62 at Kentontown, via Louderback Lane to the junction with KY 1504, a distance of 2.286 miles. (MP 0.000 to MP 2.286)
