STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Wayne County is current as of January 25, 2023. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85500 on August 15, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

KY 90, from the Clinton County Line, via Susie, the Monticello Bypass and Frazer, to the Pulaski County Line, a distance of 25.246 miles. (MP 0.000 to MP 25.246)

STATE SECONDARY SYSTEM

KY 90X (Business), from the junction with KY 90 (Monticello Bypass), via Albany Street, South Main Street, Court House Square and North Main Street in Monticello to another junction with KY 90 (Monticello Bypass), a distance of 3.535 miles. (MP 0.000 to MP 3.535)

KY 92, from the junction with KY 90 to the junction with KY 90X (Business) in Monticello. Also, from another junction with KY 90X (Business), via Oil Valley, Barrier, Coopersville, and Kidds Crossing to the McCreary County Line, a distance of 14.591 miles. (MP 7.536 to MP 8.922)(MP 8.922 to MP 22.127)

RURAL SECONDARY SYSTEM

KY 92, from Lake Cumberland, via Parnell and Swifton to the junction with KY 90, a distance of 7.536 miles. (MP 0.000 to MP 7.536)

KY 167, from the Tennessee State Line via Mt. Pisgah, Sumpter, Cooper, Wray Gap and Number One to the junction with KY 90X (Business) in Monticello, a distance of 20.037 miles. (MP 0.000 to MP 20.037)

KY 196, from the beginning of state maintenance, north of the 4-H Camp Roads to the Russell County Line, a distance of 3.321 miles. (MP 0.000 to MP 3.321)

KY 200, from the Clinton County Line, via Sandclift, Sunnybrook, Powersburg, Hidalgo, Shearer Valley, and Bethesda to the junction with KY 167, south of Monticello, a distance of 17.645 miles. (MP 0.000 to MP 17.645)

KY 674, from the beginning of state maintenance on Bugwood Road, via Old Jamestown Road to the junction with KY 92 near Parnell, a distance of 4.205 miles. (MP 0.000 to MP 4.205)

KY 696, from the Clinton County Line to another point on the Clinton County Line. Also, from the Clinton County Line via Gap Creek to the junction with KY 1009, a distance of 2.149 miles. (MP 0.000 to MP 0.840)(MP 0.840 to MP 2.149)

KY 761, from the beginning of state maintenance east of Lake Cumberland to the Pulaski County Line, a distance of 2.785 miles. (MP 0.000 to MP 2.785)

KY 776, from the junction with KY 92, southeast of Monticello, via Gregory and Denney to the end of state maintenance at the west limits of the bridge over Lincoln Creek, a distance of 12.207 miles. (MP 0.000 to MP 12.207)

KY 789, from the junction with KY 92, northwest of Monticello, via Eadsville, to the end of state maintenance at the Camp Earl Wallace Boundary near Lake Cumberland, a distance of 7.318 miles. (MP 0.000 to MP 7.318)

KY 790, from the beginning of state maintenance on Big Sinking Road to the junction with KY 776 at Gregory. Also, from another junction with KY 776, via Delta and Kidder to the Pulaski County Line, a distance of 10.337 miles. (MP 0.000 to MP 1.322)(MP 1.322 to MP 10.337)

KY 833, from the junction with KY 92 to the junction with KY 1275, north of Monticello, a distance of 3.674 mile. (MP 0.000 to MP 3.674)

KY 834, from the junction with KY 200 at Hidalgo to the junction with KY 90 near Susie. Also, from another junction with KY 90 at Susie to the junction with KY 1546 near Ramsey Island, a distance of 7.059 miles. (MP 0.000 to MP 3.827)(MP 3.827 to MP 7.059)

KY 858, from the junction with KY 90 to the junction with KY 200 near Bethesda, a distance of 1.720 miles. (MP 0.000 to MP 1.720)

KY 1009, from the beginning of state maintenance at the southeast limits of the bridge over Otter Creek at Slickford to the junction with KY 200. Also, from another junction with KY 200, via Windy and Wait to the Clinton County Line, a distance of 11.568 miles. (MP 0.000 to MP 3.200)(MP 3.200 to MP 11.568)

KY 1258, from the junction with KY 167 at Sumpter to the junction with KY 92, a distance of 3.324 miles. (MP 0.000 to MP 3.324)

KY 1275, from the junction with Kelly Lane at Spann to the junction with KY 90X (Business) in Monticello. Also, from another junction with KY 90X (Business) in Monticello, via Mill Springs, to the junction with KY 90 at Touristville, a distance of 14.355 miles. (MP 0.000 to MP 3.995)(MP 3.995 to MP 14.355)

KY 1546, from the beginning of state-maintenance at the Lake Cumberland Boys' Camp (including the entrance drive to the Camp), via Cabell, Ramsey Island and Murl, to the junction with KY 90, a distance of 9.010 miles. (MP 0.000 to MP 9.010)

KY 1619, from the junction with KY 90 at Touristville, via Betsey to another junction with KY 90, a distance of 6.677 miles. (MP 0.000 to MP 6.677)

KY 1720, from the junction with KY 92 near Swifton to the junction with KY 789 near Eadsville, a distance of 1.993 miles. (MP 0.000 to MP 1.993)

KY 1756, from the beginning of state maintenance, north of Griffin extending north, via Rockybranch to the junction with KY 92, a distance of 2.958 miles. (MP 0.000 to MP 2.958)

KY 1765, from the junction with KY 1275 to the end of state maintenance at the U.S. Army Corps of Engineers boundary line, a distance of 0.978 mile. (MP 0.000 to MP 0.978)

KY 2393, from the junction with KY 1275, extending north to the end of state maintenance at a point 2.895 miles from the beginning, a distance of 2.895 miles. (MP 0.000 to MP 2.895)

KY 3106, from a junction with KY 1275 in Monticello to another junction with KY 1275, northeast of Monticello, a distance of 4.361 miles. (MP 0.000 to MP 4.361)

KY 3282, from the junction with KY 90 near Touristville, via Old KY 90 Loop Road and Carr Road to the junction with Mystic View Road (west edge of road surface), a distance of 2.545 miles. (MP 0.000 to MP 2.545)

KY 3283, from the junction with KY 833, via Normans Road, to the end of blacktop at a point 0.818 mile north of Sally Burnett Road, a distance of 1.708 miles. (MP 0.000 to MP 1.708)

KY 3284, from the junction with KY 90 in Monticello to the junction with KY 92, a distance of 4.660 miles. (MP 0.000 to MP 4.660)

KY 3285, from the junction with KY 776 to the junction with KY 1275 at Spann, a distance of 4.193 miles. (MP 0.000 to MP 4.193)

KY 3286, from the junction with KY 92 at Kidds Crossing to the end of state maintenance to the junction with Nathan Haynes Road, a distance of 1.800 miles. (MP 0.000 to MP 1.800)

KY 3287, from the beginning of state maintenance at the intersection of Catron Hollow Road and Everett Betram Road to the junction with KY 200 near Sunnybrook, a distance of 0.947 mile. (MP 0.000 to MP 0.947)

SUPPLEMENTAL ROADS

KY 1479, from the junction with Blue Hole Road at Burfield to the junction with KY 92 at Barrier, a distance of 3.546 miles. (MP 0.000 to MP 3.546)

KY 1568, from the beginning of state maintenance of Taylor Cemetery Road to the junction with KY 90 at Frazer, a distance of 2.687 miles. (MP 0.000 to MP 2.687)
