spot improvement will involve a rural section and is expected to be located in an area that begins 1.0 km southwest of Four Mile Creek and extends to a point 4.2

km northeast of Four Mile Creek.

There are \$5,000,000 of construction funds in the Six Year Plan for this project. The limits of the second spot will be controlled by the remaining funds available

after the first spot has been considered.


