SPECIAL INSTRUCTIONS	<p>The Department reserves the option to modify the selected consultant's agreement to include any necessary engineering and/or related services for this project. The firm will be, at that time, pre-qualified by the Department in the required area(s).</p> <p>A maximum of 4 firms will be selected with each firm receiving a one-year with a one-year renewable, unit price, statewide contract. If a firm declines a project or does not respond to an invitation to perform services for a project within fourteen days, documentation shall be placed in the project files and another firm on the list shall be offered the project.</p>

<b>SCOPE</b>	Four statewide consultant contracts will be negotiated to perform aerial and photogrammetric services for projects on county, state, and federally funded Cabinet highway projects as well as full flight coverage for specified counties on an as needed basis. Mapping data will be required in digital format, with ASCII files containing digitized breaklines and random point data to be used for digital terrain modeling. Survey reports shall be submitted in digital format and shall be in PDF format. One (1) copy of all files and data shall be submitted to KETCH central Office and two (2) copies of all files and data shall be sent to the appropriate District Office. Projects will be assigned by letter agreements.
