The ending mile point 12.19 shown on the map in the advertisement is incorrect. MP 12.9 is right at the western ramps of the I65 Interchange.

statewide basis, evaluating on a specific location is not appropriate. Evaluation Factor #5 has been removed. Knowledge of, and experience at, "state-owned" airports, including Capital City Airport (Frankfort, KY), KY Dam Village State Resort Park Airport (Gilbertsville, KY), Lake Barkley State Resort Park Airport (Cadiz, KY), and Rough River State Resort Park Airport (Falls-of-Rough, KY).
