I. PROJECT DESCRIPTION

County – Simpson Route – KY 100 Item No. – 3-8307.00 Project Description – Major widening to four lanes from KY 1008 to Interstate 65 near Franklin.

II. PROJECT INFORMATION

III. PURPOSE AND NEED

Widen KY 100 to a four-lane, depressed median roadway to construct the ultimate typical section as proposed by the original KY 100 reconstruction plans in 1989.

The purpose of the project is to increase capacity, improve safety, and provide greater connectivity on KY 100 the main east-west corridor through Simpson County between Interstate 65 and the city of Franklin. By addressing the purpose of this project, the Cabinet seeks to maintain an existing facility, improve a corridor that serves stakeholders from various communities within the state's transportation system, and support the overall quality of life of the public.


XVI. EVALUATION FACTORS
