III. P URPOSE AND NEED

- A. The purpose of this project is to replace a 46 year stringer/girder bridge (007C00048N) on CR 1327 over the Left Fork of Straight Creek approximately 0.1 miles west of the junction with KY 66 in order to provide a safe, reliable roadway for those traveling from Buffalo Branch Road to KY 66 in Bell County. This project is needed because the structure has been classified as Structurally Deficient. There are a few major problems with this bridge including cracking on the deck, honeycombing, spalling in beam areas, as well as corrosion. The Sufficiency Rating is currently shown as 2.0
- B. The purpose of this project is to replace a 25 year old box beam bridge (061B00086N) on KY 3437 over the East Fork of Lynn Camp Creek approximately 0.1 miles west of the junction with KY 1232 in order to provide a safe, reliable roadway for those traveling between Knox County and Laurel County. This project is needed because the structure has been classified as Structurally Deficient. There are a few major problems with this bridge including alignment issues, cracking, and rusting. The Sufficiency Rating is currently shown as 19.2.

V. SCOPE OF WORK

The selected Consultant will be required to conduct Preliminary Engineering Studies to identify appropriate typical section, line and grade, and dependable cost estimates. The environmental document at this time is expected to be CE Level 1 which will be done by the Department.

The selected Consultant will provide engineering services to perform Phase II Roadway Design which may be added by contract mod. Services to be provided include drainage design, right-of-way plans, and construction plans, traffic control plans, cost estimates by contract mod.


