This document constitutes a Request for Proposals for Personal Service Contract from qualified individuals and organizations to furnish those services as described herein for the Commonwealth of Kentucky, Department of Highways.

I. PROJECT DESCRIPTION

County – Fayette Route –KY 4 Item No – 7-113.00

Project Description – New Circle Road Re-Hab and Widening from Versailles Road Interchange to near the Georgetown Road Interchange.

II. PROJECT INFORMATION

III. PURPOSE AND NEED

The purpose of this Project is to Evaluate Capacity and Assess Deficiencies on New Circle Road (KY 4) from the Versailles Road Interchange to near the Georgetown Road/New Circle Road Interchange. Currently New Circle Road operates at an undesirable Level of Service (LOS), especially during the AM & PM rush hours.

V. SCOPE OF WORK

The Selected Consultant will be required to provide Phase I Roadway Design, including the preparation of Engineering Studies, Identification of appropriate Typical Sections, identifying any Utility Impacts, performing Drainage Design, Developing dependable Cost Estimates, preparing documents for possible Public Meetings and providing documents and/or plans to be used in obtaining an Approved Environmental Document which is anticipated to be a CE Level 3.

As part of the Phase I Design the Consultant will be required to evaluate future improvements to New Circle Road (KY 4) and the Interchanges of Old Frankfort Pike and Leestown Road (The Interchanges) to the extent that New Circle Road will operate at a desirable Level of Services in the future Design Year.

The Consultant will also be required to evaluate improvements to New Circle Road and the Interchanges that will have an immediate improvement to the operation of the Roadway at Current Traffic Counts but will "dovetail" with future "Ultimate" Improvements that are anticipated to be made to New Circle Road for it to operate at an acceptable Future Level of Service. The Goal of the Immediate Improvements would be achieved within the Existing Right of Way or with minimal Right of Way Acquired.

As part of Phase I Design, the consultant will also be responsible for the preparation of an approved Environmental Document for this project. It is currently anticipated that this will be a CE Level 3.

This project can be advanced to Phase II Design with a Contract Modification. The Cabinet reserves the right to advertise the entire 3.4 mile corridor to Phase II Design or break it into Sections for Phase II Design. The Cabinet also reserves the right to advertise the entire project or parts thereof for Phase II Design.

VI. SPECIAL INSTRUCTIONS

The Department may retain any of the advertised services to be performed by in-house state forces.
