QUESTION: Evaluation Factors Section, number 5, indicates that after the review of responses, the selection committee will invite respondents deemed qualified for the work to submit additional information regarding the teams approach to projects. Then the selection committee will determine the best qualified firm. Does "respondents deemed qualified" refer to the 3 consultants that will be selected to provide services, of which 1 consultant will be selected for each individual LPA project as they come out? Or will there be many consultants (more than 3) asked to provide this additional information, and then 3 will be selected from that group?

RESPONSE: After reviewing the response to the announcement for the Statewide LPA General Services advertisement, the selection committee may deem it necessary to request additional information from all or some of the respondents. This may take the form an interview or the submission of additional information. We do not expect the selection committee to exercise this option for interview or additional information, however, it is a possibility and responding firms should be aware.
