I. PROJECT DESCRIPTION

County – Warren
Route – US 31W
Item No – 3-199.00
Project Description – Widen to five (5) lanes from 1.0 south of KY 242 to Dillard Road.

III. PURPOSE AND NEED

US 31W is vital and heavily traveled connection between Bowling Green and Franklin and passes through an area that is experiencing a high rate of industrial, commercial, and residential development along with the largest middle and high school campus in Kentucky. This increasing traffic is creating safety and mobility issues for motorists and commercial vehicles along the corridor.

The project was identified as the No. 1 transportation need for District 3 in the District Transportation Plan and by the Bowling Green/Warren County MPO 2011 prioritization. Resulting from those recommendations, a project is identified in the FY 2012-2014 Enacted Biennial Highway Plan.

The purpose of this improvement is to address the existing and future safety and congestion issues along US 31W and to provide a safe and reliable connection from Franklin to Bowling Green.

Contrary to the project description in the Enacted Highway Plan, the project will begin near the Buchanon Park entrance (MP 4.1) and end at Dillard Road (MP 6.684)

IV. SCOPE OF WORK

The selected consultant will be required to provide engineering services to perform Preliminary Engineering and Final Roadway Design. Preliminary Engineering includes line and grade plans, traffic engineering analysis as per Design Memo 03-11, preliminary drainage, and cost estimates. Final Roadway Design includes, at a minimum, preparation of drainage design, right-of-way plans, construction plans including storm water construction and post construction Best Management Practices (BMP), signing and pavement marking plans, traffic control plans, final cost estimates, and an anticipated construction schedule.
