A REQUEST FOR PROPOSAL FOR PERSONAL SERVICES CONTRACT

This document constitutes a Request for Proposals for Personal Service Contract from qualified individuals and organizations to furnish those services as described herein for the Commonwealth of Kentucky, Department of Highways.

I. PROJECT DESCRIPTION

County – Jefferson Route – KY 864 Item No – 5-481.00

Project Description – KY- 864- Widen Beulah Church Rd from 2 to 3 lanes from I-265 Interchange to Cedar Creek Rd.

II. PROJECT INFORMATION

III. PURPOSE AND NEED

The purpose of this project is to address the increasing traffic demand in a rapidly developing section of Louisville in an effort to increase access, safety and mobility.

KY 864 Beulah Church Road is an urban collector with many access points and carries traffic from growing residential suburbs to the Gene Snyder Freeway (I-265) and downtown. Growth is expected to continue. Currently Cooper Chapel Road is in design to extend to Bardstown Road (US 31E), which will bring additional traffic to the route.

IV. DBE REQUIREMENT

The consultant team shall include a DBE Participation Plan with their response to announcement. An additional page will be allowed with the project approach in the Response to Announcement to convey this plan. A maximum of 4 points will be considered in the evaluation factors for the DBE Participation Plan.

V. SCOPE OF WORK

The selected consultant will be required to provide engineering services for Preliminary Engineering to determine the typical section, line and grade, drainage, and preliminary construction cost estimates for the different alternatives, including spot improvements as needed for the proposed reconstruction of KY 864. The selected consultant may then be required to provide engineering services to perform Final Roadway Design.

The initial contract will be for Preliminary Engineering services only. The project may be advanced to Final Roadway Design, with a Contract Modification.

The Structure Design will be performed by the Cabinet. Structure Design Services may be added to the contract agreement by contract modification. Prequalification in the area of structure design is required to be identified in the consultant's Response to Announcement.

The Department will provide all Geotechnical Services required for the project.

The Department will provide all the necessary traffic projections and related information required for this project.

The Selected Consultant will assist the Department with Utility Plans.

The Selected Consultant will provide Subsurface Utility Engineering (SUE) work to field-locate utilities as needed. Horizontal and vertical location of existing utilities shown on Final Roadway Design plans shall be adjusted by the consultant as necessary to reflect actual SUE results.
