QUESTION: The Bulletin gives the project limits as 9.6 to 11.7. The DNA Study done in January of 2013 shows on the cover "revised to M.P. 10.6 to 13.1" and also indicates in Section IIB that the "Highway Plan description should read - "raise grade to prevent flooding from 0.5 mi East of Valley View Dr. to 0.7 MI East of KY 1258". These refer back to 10.6 to 13.1. Please clarify the project limits.
RESPONSE: The intent of the project, as defined in the Road Plan, is to "Raise Grade to Prevent Flooding". There was an error in the description of the project limits as written in the Road Plan, and the District did not feel comfortable advertising a project with a description other than that posed in the plan. However, the District has a good understanding of where the flooding limits extend to, and discussions will be held with the selected consultant to specifically address the project limits.
