This document constitutes a Request for Proposals for a Professional Service Contract from qualified individuals and organizations to furnish those services as described herein for the Commonwealth of Kentucky, Department of Highways.

I. PROJECT DESCRIPTION

County – Warren, Butler, Ohio and Daviess Counties Route – William H. Natcher Parkway (WN 9007)

Item Nos. – 02-2092.00 / 03-2042.00

Project Description - Modernize the existing William H. Natcher Parkway by reconstructing

certain elements of the Parkway between Interstate 65 (MP 2.079) in Bowling Green, KY and US 60 (MP 72.264) in Owensboro, KY in order to meet the congressional intent to have the route reclassified as an Interstate Spur. This project only entails the modernization of the Parkway. Separate project advertisements are anticipated for three interchange reconstruction projects at Exits 9, 36 and 50 that are also required for reclassification of

the route.

III. PURPOSE AND NEED

The purpose of this project is to make the necessary improvements to the William H. Natcher Parkway between Bowling Green, KY and Owensboro, KY in order for the facility to be accepted into the interstate system as an interstate spur. The need is defined by substandard conditions for an interstate facility as explained in the *I69, I66/I65 Spurs and US60 Connection Strategic Planning Corridor Study* issued in 2014.

IV. DBE REQUIREMENT

The Consultant shall include a DBE Participation Plan with their Response to Announcement. An additional page will be allowed with the Project Approach (page 7) in the Response to Announcement to convey this plan. A maximum of 4 points will be considered in the Evaluation Factors for the DBE Participation Plan.

V. SCOPE OF WORK

The selected Consultant will be required to provide Preliminary Engineering services by supplementing the referenced planning study above with further field inventory and engineering analysis to support KYTC in finalization of an agreement with the Federal Highway Administration on what upgrades are necessary and what deficiencies can be accepted into the interstate system through design exceptions and variances. The Consultant will then be required to provide Preliminary Engineering services to develop those proposed improvements defined within the agreement to a preliminary line and grade stage.

This project may be advanced to Final Engineering services with a Contract Modification. If desired, the selected Consultant will then be required to provide engineering services to perform Final Roadway Design, including the preparation of any design studies, drainage design, right of way plans, construction plans, traffic control plans, and cost estimates.

IX. ENVIRONMENTAL

The Department will be responsible for the Environmental Documentation, which is anticipated to be a Categorical Exclusion Level 3.

X. GEOTECHNICAL SERVICES

The Department will provide all Geotechnical Services required for the project if necessary.

XI. STRUCTURE DESIGN

The selected Consultant shall do the necessary engineering service to submit to the KYTC an Advanced Situation Folder(s) for the appropriate applicable structure(s). The Structure Design may be performed by the Consultant. Structure Design services may be added to the Contract by Contract Modification. Prequalification in the area of Structure Design is required to be identified in the Consultant's Response to Announcement.

XII. TRAFFIC

Traffic projections and related information will be provided by the Department.

XIII. SURVEY SERVICES

The Consultant will be responsible for obtaining mapping to support the preliminary engineering phase from existing resources. The Consultant may also be responsible for conventional surveying to supplement the mapping as needed for final plan development.
