**QUESTION:** The prequalification requirements for the subject RFP include Photogrammetry & Related Services but the RFP indicates that KyFromAbove should be used for aerial photography and LiDAR and supplemented with conventional surveying. Since this is the case, is the prequalification necessary since we would not anticipate needing those services?

**QUESTION:** Please clarify that the data within the OMS will be used to identify problem slopes and inform the prioritization of unstable slope sites, or if data generated from the study will be input into the OMS by the Consultant.

**ANSWER:** The selected Consultant will not be required to input data into OMS.

**QUESTION:** The RFP states that any necessary Environmental Services are likely to be provided by the Consultant, and that if needed, an Environmental Overview Report with a red flag summary may be included in the final report. Please clarify if the Environmental Overview Report will be required as part of the Consultant's final report.

**ANSWER:** The Cabinet has revised the RFP to change "included" to "required" to read "If needed, an Environmental Overview Report with a red flag summary may be required in the final report." Please see <u>Section IX</u>. Environmental <u>Services</u> of the RFP for more information.

**QUESTION:** Does KYTC have a formal or informal slope inventory rating system that should be used on the project, or will the Consultant be responsible for proposing a rating system that meets project objectives?

**ANSWER:** Per Geotech Branch, KYTC does not have a formal or informal slope inventory rating system and would be open to any suggestions provided by the Consultant through this study.

**QUESTION:** Would KYTC consider extending the due date by two weeks. The new deadline would be June 19th?

**ANSWER:** The Procurement Schedule will remain as-is with a Response Due date of June 5<sup>th</sup>.

## <u>2024-11 – Statewide Structural Steel Shop Inspection Services</u>

**QUESTION:** Are DBE subconsultants required to be prequalified with KYDOT in the category of Construction Engineering Services, Structural Steel Fabrication Inspection prior to being submitted in the RFP response or contract execution?

**ANSWER:** Firms must be prequalified by the time of RFP response to be included on a team for selection; however, any firm prequalified by the time of contract execution will be counted towards our DBE goal.

**QUESTION:** What is a "prefabricated" product with respect to the following sentence located under Section <u>VI. Special Instructions</u> on page 2 of the above referenced RFP: "Travel time is not paid by the KYTC except on prefabricated structures."

**ANSWER:** This has not yet been required but the Cabinet may consider reimbursing for travel time if an instance arose where we required the Consultant to send an inspector for a very short period of time, e.g. to perform a quick inspection before loading and shipping.
