

**SUBJECT:** Notification of **Administrative Modification #8** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #27 to the 2045 Metropolitan Transportation Plan (MTP)

---

On October 19, 2021, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #8 to the FY 2021 – 2024 TIP and Modification #27 to the 2045 MTP.

### **Administrative Modification #8:**

This action updates the previously published documents and tables. These modifications are considered Grouped Projects\* (Highway Safety Improvement Program and Bridge Replacement) which do not impact the financial constraint of the TIP.

The first modification adds the following safety project in Fayette County:

- **KY 57 Low Cost Safety Improvements:**  
Perform low cost safety improvements on KY 57 from MP 1.292 (just east of I-75) to MP 7.800 (just west of Haley Rd.)
  - Construction phase: \$1,710,000 (Federal HSIP funds) + \$190,000 State Match = \$1,900,000 total

The second modification updates an existing project in Jessamine County by adding the utilities phase:

- **North 3<sup>rd</sup> Street Bridge:**  
Address deficiencies of RR bridge on KY 169 between Meadowlark Ln & Ilhardt Av
  - Utilities phase: \$188,000 (Federal STBG funds) + \$47,000 State Match = \$235,000 total

*\* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).*
