**SUBJECT:** Notification of **Administrative Modification #26** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #44 to the 2045 Metropolitan Transportation Plan (MTP)

---

On February 13, 2023, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #26 to the FY 2021 – 2024 TIP and Modification #44 to the 2045 MTP.

### **Administrative Modification #26:**

This action updates the previously published documents and tables. These modifications are considered Grouped Projects\* (Bicycle and Pedestrian, Intelligent Transportation System (ITS) and Replacement Bus Purchases) which do not impact the financial constraint of the TIP. The modification updates an existing project, and adds two new projects funded through recently awarded Congestion Mitigation Air Quality (CMAQ) grants:

#### **West Loudon Streetscape (Existing Project)**

This update brings \$30,000 in STBG-TA funds (\$20,000 ROW + \$10,000 Utilities) that were not obligated in the previous TIP forward to the current TIP, and moves \$72,000 in STBG-TA funds from Construction to ROW.

#### **Fiber Optic Extension (New CMAQ):**

This project extends the existing fiber optic cable network to enhance traffic signal and video monitoring capabilities along Man o' War Boulevard from Fort Harrods Drive to Versailles Road and along Versailles Road from Man O' War Boulevard to Parkers Mill Road inside New Circle Road. This \$750,000 project will be funded with \$600,000 in federal CMAQ funds plus a \$150,000 local match provided by the City of Lexington.

#### **Lextran Fixed-Route and Paratransit Vehicles (New CMAQ):**

This project replaces four aging diesel transit buses with four compressed natural gas (CNG) transit buses and six aging gasoline cutaway vehicles with six hybrid-electric cutaway vehicles. This \$3,750,000 project will be funded with \$3,000,000 in federal CMAQ funds plus a \$750,000 local match provided by Lextran.

*\* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential*

projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
