SUBJECT: Notification of **Administrative Modification #31** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #49 to the 2045 Metropolitan Transportation Plan (MTP)

On May 15, 2023, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #31 to the FY 2021 – 2024 TIP and Modification #49 to the 2045 MTP.

Administrative Modification #31:

This action updates the previously published documents and tables. The modification add one Grouped Project* (Intersection Improvements for Safety or Efficiency) which does not impact the financial constraint of the TIP:

Georgetown Road at Innovation Drive

This modification adds a project to improve the intersection of Georgetown Road at Innovation Drive:

\$426,648 state SPP funds + 200,000 local match = \$626,648

* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
