SUBJECT: Notification of **Administrative Modification #34** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #52 to the 2045 Metropolitan Transportation Plan (MTP)

On July 5, 2023, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #34 to the FY 2021 – 2024 TIP and Modification #52 to the 2045 MTP.

Administrative Modification #34:

This modification adds one new Grouped Project* (Highway Safety Improvement Program projects), which does not impact the financial constraint of the TIP:

D7 Wrong Way Signs:

This modification adds a project to install wrong way driving signs and pavement markings on various off ramps in District 7. Note that not all of the sign installations will be in the MPO area (Fayette & Jessamine Counties).

- 100% federal HSIP funds = \$1,468,000

* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
