SUBJECT: Notification of Administrative Modification #2 to the FY 2025 - FY 2028 Transportation

Improvement Program (TIP) and Administrative Modification #5 to the 2050 Metropolitan

Transportation Plan (MTP)

On February 4, 2025, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #2 to the FY 2025 – 2028 TIP and Modification #5 to the 2050 MTP.

#### **Administrative Modification #1**:

This modification adds a project and makes a correction to the description of an existing project. The new project is classified as a Grouped Project<sup>1</sup> (Highway Safety Improvements), which does not impact the financial constraint of the TIP.

### West Main & Buchanan Safety Improvements (MTP ID: FAY-205)

• Add the RW, UT and CN phases (\$1,017,000 SLX (80%) + \$254,000 State Match (20%) = \$1,271,000). The DN phase was funded in the previous TIP and has been completed.

#### Harrodsburg Rd Trail Sec 1 (MTP ID: FAY-214A)

 This project was recently added under Modification 1 with the incorrect project limits; Lane Allen to New Circle Road. This modification updates the description with the correct project limits; Man O' War Blvd to Dogwood Trace/Overlake Blvd, and corrects the MTP ID from FAY-191 to FAY-214A
